U.S. REIMBURSEMENT POLICY IN FLUX: WHAT MEDTECH NEEDS TO KNOW NOW BY TONYA DOWD

Tonya Dowd penned this informative article, describing shifts in the U.S. health policy, and why MedTech companies can no longer afford to assume a status quo reimbursement environment. It touched on CMS proposals related to payment equity, quality care, price transparency and reduction of fraud, waste, and abuse. Readers were informed and advised about how expanded quality reporting and equity-driven metrics will affect technologies utilized primarily in higher-cost hospital settings, as well as the impact of commercial-style prior authorization to traditional Medicare in the WISeR Model, reviewed in further detail in the July 31 webinar.
