GENERAL RELEASE AND WAIVER OF LIABILITY

The undersigned, _____ [print name], a paid participant in a training or educational class or program provided by CDG Tactical Ops, LLC [hereafter "CDG"], in consideration for the education, experience, and training provided by CDG, the receipt and sufficiency of consideration is hereby accepted and acknowledged, does hereby release, waive, satisfy, and forever discharge and settle any and all claims, demands, causes of action, suits, controversies, judgments or damages of any kind or nature whatsoever, in law or in equity, which exist or may arise against CDG and/or its successors, heirs, assigns, employees, appointees or agents, relating to any and all participation, in whatever activity or form, including but not limited to, injury, illness or death, and/or damage to, or loss of, personal property.
