The Boze Family Legacy

The Boze Family has been in the funeral service profession for three generations. Wayne's grandfather, Arthur T. Boze, was the first licensed mortician in Ellis County. He was licensed in November 1914 while working for Spalding Furniture Company & Undertakers, the humble beginnings of the funeral industry in this community. By 1937, Martin-Boze Funeral home had become Boze-Ashcraft Funeral Home. When Arthur Boze died on March 12, 1937, Wayne's father Pat became a partner in his father's place at the age of 17. He was licensed in November 1939 and was thereafter involved in several partnerships including Champion-Boze, Saxon-Boze, Saxon-Boze-Mitchell, and finally for over fifty years, with Boze-Mitchell Funeral home.

In 1985, Boze-Mitchell Funeral Home sold to Centurion National Group and in 1986 to Service Corporation International (SCI). In 1988 Wayne moved back to Waxahachie after an 18-year absence. He became a licensed director/embalmer while working for SCI at Boze-Mitchell Funeral Home.

From April 1993 until October 15, 1996, Wayne worked for Mt. Olivet Funeral Home while still planning for and dreaming of a privately owned, family operated funeral establishment.

Wayne Boze Funeral Home opened its doors for business on Monday, February 2, 1997. Wayne Boze Funeral Home was expanded in December 2004 with the purchase of Red Oak Funeral Home.

Our first year in business was a whirlwind of activity, and experience filled with excitement, challenges, joy and sadness. Mr. Pat Boze died on November 13, 1998 at 10:33 P.M. with his family in attendance to witness the light fade from his eyes as he drew his final breath. Before he died, Pat placed his stamp of approval on the work that we are carrying on here in Waxahachie by his presence and his loving support. His **LEGACY OF SERVICE TO MANKIND**, which we are heirs to, remains fresh in our hearts and in our minds. It is at the very core of the philosophy we expound, promote, teach, and strive to maintain in every act we perform as we minister to our client families.

Funeral Selection and Financial Policy

Funeral service costs are itemized. You may select or reject various items, all of which will be explained to you prior to making any selections. We want you to select the type of service and burial you prefer; at a cost you can afford. Your itemized Funeral Purchase Agreement will be reviewed with you, and one or more responsible parties will be asked to sign the acceptance agreement to pay for services. You will be provided with a copy of the completed financial agreement.

In order to assure that the quality of service remains at the level our families have come to expect, we ask for your cooperation with the following financial arrangements:

Payment for services is due in full at time the arrangements. We accept cash, check, MasterCard, Visa, and Discover. We will also accept an assignment of confirmed life insurance proceeds provided the policy has been in force for over two years. Contracts being secured through insurance proceeds will be subject to a 5% fee of the contract total, to process each insurance assignment. Life Insurance companies that do not accept insurance assignments from a funeral home will not be accepted as a form of payment.

Contracts that exceed 30 days of not being fully funded will be subject to a charge at the rate of 1.5% per month, 18% annually.

Death Certificates

Wayne Boze Funeral Home will process the death certificate for each family. The certified copies of the death certificate are usually available to the family within 6 weeks. This process can be delayed depending on the availability of the physician. If death occurs outside of Ellis County, this process may incur an additional delay. In certain circumstances when it is determined that the Medical Examiner is the one to sign the death certificate, and the cause of death cannot be immediately determined, the certificate is placed in pending status. While in the pending status, the death certificate will not be certified and could take as long as six months for the cause of death to be determined by the Medical Examiner. Immediately upon receipt of the certified copies of the death certificate, you will be contacted by our business office.

Cash Advance Items

When arranging a funeral there may be payments to other parties such as the cemetery service for the opening and closing of the grave, cemetery fees, newspapers, clergy, musicians, etc. which will need to be made. The funeral home will make these payments, which are referred to as cash advances, on your behalf. Some of these, such as clergy honorarium, are gifts and are subject to your discretion. These amounts will be itemized on your funeral purchase agreement and must be paid at the time of arrangements.

Policy for Handling Unembalmed Bodies

There are no laws requiring that a body should be embalmed. You may select a service such as direct cremation or immediate burial which does not require embalming. The funeral home reserves the right to decline to conduct a service for a deceased person who has not been embalmed if the service is to be beyond 24 hours from the time of death. For embalming to be the most beneficial, a decision on whether or not to embalm should be made as soon as possible. In any case, state law requires that embalming, refrigeration, immediate burial, or direct cremation occur within 24 hours following death. As a general policy, we will permit only the deceased's immediate family to view an unembalmed body. This viewing shall be limited to a brief period not to exceed one hour. For safety reasons we will not open casket at cemetery. When selecting burial clothing for your loved one, bear in mind that we will not undress the body to return clothing to the family.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire, however, any arrangements you select will include a charge for our basic service and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Package Services

The following packaged services are those most frequently requested by families we serve. We have prepared these selections to include a discount from the total cost of the individual items included. You may add any additional items or services to these offerings, but no credit will be given for those items, which are listed in the offering you elect not to use. The packages listed on this page are only offered in conjunction with the purchase of a casket selected from our casket price list. The fees listed do not include charges for casket, outer burial container, cemetery service, excess mileage, clothing, limo transportation for family or pallbearers, burial of cremated remains or specific cash advances incurred by the funeral home for your convenience. Many people are not aware that a cremation does not limit the type of service you may select. Should you have specific request different from these choices, please consult with your funeral director to arrange the most appropriate tribute possible.

Itemized Selections

Professional Services:

Services of Funeral Director and Staff \$2995.00

Our fee for our staff includes, but are not limited to, staff to respond to the initial request for service; arrangement conference with family and/or responsible party; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notices; staff assistance prior to, during, and following the funeral; including coordination with those providing other portions of the funeral, such as, clergy, cemetery, crematory, and others. Also included in this charge are overhead expenses relative to our facility such as insurance, taxes, maintenance and utility expenses, secretarial and administrative cost, and equipment and inventory cost. **This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select.** (This fee is already included in our packages, and charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Embalming \$795.00

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Additional charge for Embalming of Autopsy Cases and/or Organ Donors \$200.00

Reconstruction/Restorative Art per hour \$75.00

Disinfection, Dressing, Hairdresser, and Casketing of the Deceased

Refrigeration \$795.00

This charge is for refrigeration of unembalmed remains for up to three days. The charge for additional days over three is **\$50.00** per day.

Crematory standard charge \$400.00

This charge is for cremation of remains following a service. It is already in our charge for a direct cremation.

*Oversized cremation charge applies to anyone in excess of 250 pounds or more than 6.5 feet tall. **\$500.00**

Receiving Anatomical Donations **\$250.00**

This charge is for the coordination and handling of human remains for anatomical donation. It does not include transfer of the deceased to the funeral home, nor embalming. Many medical schools require that arrangements for anatomical donation is made prior to death.

Staff, Facilities, and Equipment:

Use of Stateroom for Visitation / Shelter of Deceased **\$325.00**

This charge includes use of facilities for lying in state and visitation, and/or other shelter of the deceased. (If this period exceeds 48 hours, a charge of **\$75.00** per additional 24 hours will be added.)

Use of Chapel for Rosary/Visitation **\$325.00**

This charge includes use of facilities for lying in state and visitation, and/or other shelter of the deceased. (If this period exceeds 48 hours, a charge of **\$75.00** per additional 24 hours will be added.)

Staff and Equipment for Traditional Graveside Service **\$595.00**

This charge includes necessary staff for supervision and direction of a traditional graveside service (no funeral procession to the cemetery) within a 30-mile radius of the funeral home, as well as incidental equipment, which might be required.

Staff, Equipment, and facilities for Chapel Service **\$595.00**

This charge includes staff, equipment, and facilities for a funeral service in our chapel, or for a graveside service where the family elects to meet at the funeral home and depart in procession to the cemetery.

Staff and Equipment for Church Services **\$595.00**

This charge includes staff and equipment necessary for the supervision and direction of a church service at a location within a 30-mile radius of our facility.

Staff, Equipment, and Facilities for Chapel Memorial Service **\$595.00**

This charge includes staff, equipment, and facilities for a memorial service (a service without a body present) in our chapel, along with coordination and supervision of the service.

Staff and Equipment for Conducting Services at the DFW National Cemetery **\$595.00**

This charge does not include cremation fees, urn, memorial book package, escorts or specific cash advance items incurred by the funeral home for your convenience.

Staff for Conducting Memorial Service at Facility Other than Chapel **\$595.00**

This charge includes services of a funeral director for the supervision and coordination of a memorial service (a service without a body present) at a facility other than our chapel.

Funeral Director and Staff Charges for Sunday Service **\$1500.00**

These charges are in addition to those listed on the GPL and are applicable as indicated for services conducted on Sundays. Service times for Sunday services may only be conducted at 2:00 p.m. Cemetery overtime fees will apply.

Funeral Director and Staff Charges for Services Scheduled after 3:30pm **\$500.00**

These charges are in addition to those listed above and are applicable as indicated for services conducted and scheduled for times 3:30 p.m. or after Mon-Sun.

Staff charges for Church Service from 30 Miles to 75 Mile Radius **\$250.00**

The funeral home provides at least three staff members to conduct a church service. This charge covers the additional time required for all staff.

Staff for Service Requiring an Overnight Stay **\$250.00**

Special Charges:

Forwarding Remains to Another Funeral Home **\$4640.00**

This charge is for minimum services required and includes the removal of remains in Ellis County, services for funeral director and staff, embalming and other preparation of the body, temporary shelter of remains (not to exceed 24 hours), necessary authorizations, transfer to DFW airport Love Field where applicable. It does not include rites of ceremonies prior to forwarding the body, facilities for visitation, air freight or shipping container or filing documents outside of Ellis County. The cost of transfer outside our local trade area (30 miles) is **\$3.25** per mile, one-way.

Receiving of Remains from Another Funeral Home **\$3670.00**

This charge includes minimum services of funeral director and staff, transfer from DFW airport Love Field where applicable, use of facilities for temporary shelter of remains (not to exceed 24 hours), and local use of funeral coach for transfer of remains to the cemetery. Additional charges for facilities or staff for services selected and any additional vehicles or other services items requested will be added to this charge.

Receiving of Remains (Cremated Remains) from Another Funeral Home **\$2900.00**

This charge includes minimum services of funeral director and staff, use of facilities for temporary shelter of cremated remains, use of staff, equipment, and facilities for conducting Memorial Service in our Chapel. This charge does not include stationary items or cash advance items incurred by the funeral home.

Direct Cremation**\$2695.00**

This charge includes removal (within 30 miles of our facility) and temporary shelter of remains (not to exceed 24 hours), necessary services of funeral director and staff, transportation to the crematory, cremation fees, authorizations, and a standard alternative container. It does not include embalming, viewing or visitation, nor any rites or ceremonies. If documentation has to be filed other than Ellis County, there will be additional charges for transport, and securing and filing of necessary legal documentation required for cremation. If you want to arrange a direct cremation, you can use an alternate container. Alternate containers encase the body and can be made of materials such as fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard and wood cremation trays with vinyl body cases.
