

Privacy Policy

BARC Builders (“we”, “us”, “our”) respects your privacy and is committed to protecting it through our compliance with this Privacy Policy. This policy describes the types of information we may collect from you or that you may provide when you visit www.barcbuilders.com (the “Site”) and our practices for collecting, using, maintaining, protecting, and disclosing that information.

1. Information We Collect

We collect several types of information from and about users of our Site:

a. Personal Information You Provide

- When you fill out a contact form, request a quote, book an appointment or otherwise contact us, you may provide us with personal information such as your name, email address, phone number, address, project details, etc.
- Correspondence: when you send us emails or messages, or otherwise communicate with us.

b. Automatically Collected Information

- Usage Data: information about your interactions with the Site (e.g. which pages you view, time spent on pages, links clicked)
- Device Information: IP address, browser type, operating system, device type
- Cookies and similar technologies: see more in section 4.

c. Third-Party Information

- We may receive information about you from third-party services (for example, if you contact us through a social media platform, or via a third-party service integrated with the Site).
- We may also use third-party analytics or advertising services which provide aggregated or anonymized data.

2. How We Use Your Information

We use information we collect about you for various purposes, including:

- To respond to your inquiries, provide quotes, schedule consultations or appointments, and communicate about projects.
- To deliver the services you request (construction, renovation, estimate, etc.).
- To improve our Site, services, and user experience.
- To send you updates, marketing communications, or notices, if you consent or as permitted by law.
- To monitor and analyze usage and trends to enhance Site functionality and security.
- To detect, prevent, or otherwise address fraud, security, or technical issues.

3. Disclosure of Your Information

We may disclose personal information that we collect, or you provide, in the following ways:

- **To our contractors, subcontractors, service providers, and partners**, who perform services for us or on our behalf (e.g. for website hosting, email delivery, analytics).
- **To comply with legal obligations**, such as responding to lawful requests by public authorities, such as courts, law enforcement, or regulatory agencies.
- **To protect our rights, property, or safety**, and those of our clients or the public.
- **In the event of a business transfer**, merger, acquisition, or sale of assets, your personal information may be transferred.

We do not sell your personal information to third parties.

4. Cookies and Tracking Technologies

We and third parties may use cookies, web beacons, embedded scripts, and other tracking technologies to automatically collect usage and device information.

- Cookies may be “session” cookies (deleted when you close your browser) or “persistent” cookies (stored until expired or deleted).
- You can usually modify your browser settings to refuse cookies or alert you when cookies are being sent. However, some parts of the Site may not function properly without cookies.

5. Third-Party Links

Our Site may contain links to third-party websites, plugins, or services. If you follow a link to any of these, please note that these third-party sites have their own privacy policies. We do not accept responsibility or liability for their policies or practices.

6. Security

We use reasonable administrative, technical, and physical security measures to protect your personal information. However, no method of transmission over the Internet, or method of electronic storage, is 100% secure; so we cannot guarantee absolute security.

7. Retention

We will retain your personal information for as long as needed to fulfill the purposes outlined in this Policy (e.g. to respond to your inquiries, provide requested services), comply with our legal obligations, resolve disputes, and enforce our agreements.

8. Your Choices

- **Access / Correction:** you can request access to or correction of your personal information.
- **Opt-out:** you may opt-out of receiving marketing emails from us by following the unsubscribe instructions in such emails.

- **Cookies:** as noted, you can disable or restrict cookies via browser settings.

9. Children's Privacy

Our services are not directed to children under the age of 13 (or higher where required by local law), and we do not knowingly collect personal information from children under that age. If we learn we have collected personal information from a child under 13 without verification of parental consent, we will delete that information.

10. International Visitors
