### Right to Vote

Except during any development period established in the Declaration, any provision in the Association's governing documents that would disqualify an Owner from voting in an Association election of Board Members or on any matter concerning the rights or responsibilities of the Owner is void. (TPC § 209.00593)

The voting rights of an Owner may be cast or given:

- A. In person or by proxy at a meeting of the Association.
- B. By absentee ballot.
- C. By electronic ballot. (internet site, Email , voicemail or Facsimile)

### Proxy Form

If you are unable to attend the annual meeting of members, you may assign another person who will attend the meeting to serve as your proxy for the purpose of establishing a quorum. You may appoint a current board member to serve as your representative.

### Electronic Ballot

- a. May be counted as an Owner present and voting for the purpose of establishing a quorum only for items appearing on the ballot.
- b. May not be counted, even if properly delivered, if the Owner attends any meeting to vote in person, so that any vote cast at a meeting by an Owner supersedes any vote submitted by absentee or electronic ballot previously submitted for that proposal.
- c. May not be counted on the final vote of a proposal if the proposal was amended at the meeting to be different from the exact language on the absentee or electronic ballot.

If you desire to retain this ability, please attend any meeting in person. You may submit an absentee ballot and later choose to attend any meeting in person, in which case any in person vote will prevail."***
