WAIVER, RELEASE & INDEMNITY AGREEMENT

To Hiland Park Country Club, its employees, directors, insurers, agents, successors, and assigns (collectively the "Club"). In consideration of being permitted to participate in and use the Club as a condition of my membership,

I _____, representing all parties in my membership (hereinafter the "Member") hereby agree as follows:

PERSONAL PROPERTY

The club is not responsible for the loss or theft of or damage to personal property on the Club's premises. Whether held in storage or not. This includes but is not limited to golf clubs, golf bags, golf accessories, money or other property. The Member will take all precautions to avoid loss or theft of, or damage to, personal property. In the event of such loss, or damage, the Member agrees to hold the club harmless from and against any and all claims, actions, costs, expenses and demands in respect to such theft, loss or damage, however caused, arising out of or in connection with the use of the club.

POWER CART RENTALS

The member agrees to assume all risk of loss or damage to motorized golf carts rented or borrowed from the Club as well as the risk of injury to the Member or other persons and damage to other property arising from the use of the golf cart. The Member will take all precautions to avoid loss or damage to the golf carts, damage to other property and injury to persons including to the Member arising out of the use of golf carts. In the event of any loss, damage or injury, the Member agrees to hold the Club harmless from and against any and all claims, actions, costs, expenses and demands in respect of such loss, damage or injury, howsoever caused. The Member agrees to indemnify and reimburse the Club for any liability, costs or expenses imposed by law upon the Club for any and all such losses.

GENERAL WAIVER

The Member acknowledges that there are risks inherent in participating in the game of golf.

The Member agrees to release the Club from any liability from personal injury, property damage or loss sustained by the Member, including injury resulting in death and any financial loss or damage directly or indirectly resulting from the Member's activities or participation in events at the Club.

The Member further waives as against the Club, all claims recourses and rights of action that the Member may have against the Club as a result of such personal injury, property damage or loss.

The Member agrees that this Waiver, Release and Indemnity Agreement shall not be affected by any negligence, gross negligence, breach of contract or any other conduct on the part of the Club. The Member acknowledges that he or she has read this Waiver, Release and Indemnity Agreement and understands and accepts the contents hereof. In the event that any provision herein contained is deemed to be unenforceable and/or invalid that the provisions shall be severable from the whole of the document and shall not affect the validity and enforceability of the other provisions and the document as a whole.

General Club Rules for 2026

Dress Code

Men's golf shirts are required to have collars and be tucked in. Golf shorts or pants. No jeans, jean shorts or cargo shorts/pants. Women's golf shirts are expected to be appropriate fashion tops. If it is sleeveless shirt, it should have a collar. No t-shirts, tank tops, cut offs, or denim are allowed. Golf skirts or shorts must be appropriate length, about mid-thigh. Golf shoes are required to have soft spikes; no metal spikes or open-toed shoes are allowed.

Food and Beverage

Golf course: Outside coolers are not allowed. Outside alcohol is not allowed.

Conduct

The Club reserves the right to refuse service to any member or guest who violates these rules.

Smoking. The Pro Shop, Range, Snack Bar, and The Clubhouse are non-smoking facilities. Smoking is only permitted outside of the buildings. Please discard all cigarette and cigar butts in the ashtray receptacles provided by Clubhouse, Pro Shop and Snack Bar.

Personal Belongings

The Club shall not be held responsible to any member or guest for the loss of property of any kind. Lost items will be held in the Pro Shop, and articles not claimed within 14 days will be disposed of or donated to an appropriate charitable organization.

Vehicles

Vehicles are permitted in authorized parking areas only. Overnight parking is allowed with the Proshop's consent.

Safety and Accidents

The Club is concerned about the safety and well-being of all its members and guests. Members and guests should immediately report any act, situation or circumstance that is unsafe to a Club staff member. If any member or guest experiences an emergency of any kind, he/she should call 911, tend to the individual's needs, and seek help from a Club staff member. If any member or guest is hurt or has an accident on the premises, he/she should immediately notify the Club so that an incident report may be completed.

Course Rules

Pace of Play

- Play is expected to be at a pace of 15 minutes per hole or less, or 4½ hours to complete 18 holes.
- Each group should keep pace with the group ahead of you.
- As a courtesy, groups should allow faster groups, including singles, twosomes, and threesomes, to play through at the earliest opportunity.
- Hiland Park Country Club reserves the right to move groups into position if they consistently fail to recognize pace-of-play concerns.

Handicaps

- GHIN is mandatory for all member who wish to play in club sanctioned tournaments.
- Every member is responsible for posting scores on the GHIN app.
- Members should post all rounds: home and away.

Golf Course

- All players are required to have their own golf club sets; players are not permitted to play out of the same bag. Clubs are available for rent in the pro shop.
- Fivesomes are not permitted without the permission of the golf shop staff.
- Golfers between the ages of 6 and 13 years must be accompanied by an adult (18 years or older) who is responsible for the children's actions.
- Golfers must repair ball marks on putting surfaces.
- Golfers must rake all bunkers.
- Players should replace the divots.
- When using the driving range, players are not allowed to retrieve golf balls.

Golf Carts

- Unlimited Carts purchase is for all cart usage throughout the season including leagues and club tournaments.
- A valid driver's license or permit is mandatory for golf cart rental.
- Groups must consolidate into a maximum of 2 carts per foursome of riding golfers.

- Golf carts may not travel within 30 feet of putting surfaces.
- Golf carts are not permitted to travel in the tall fescue grass areas.
- Push carts are not permitted in the tall fescue grass areas.
- For safety, golf carts MUST remain on cart paths on all par 3 holes and must be at least 30 feet away from the tee box and green.
- Members and guests operating a Club-owned golf cart will be held fully responsible for any and all damages to the golf cart or golf course while the cart is in their possession.
- Any negligent use, or reported negligent use of golf carts in your possession will result in loss of golf cart privileges.
- Handicap cart flags/plaques will be available for those with a medical condition and preexisting handicap license.

Tee Times

- Members may reserve tee times up to 7 days in advance. Subject to change.
- Public can reserve tee times 7 days in advance. Subject to change without notice.
- Reserved tee times that are canceled with less than 24 hours advance notice will be subject to the following fee: \$25 per person charged directly to your House Account
- Reserved tee times that are "no-shows" will be charged the daily rate directly to your House Account.

Practice Range

- One person per tee/stall
- For your safety, walking beyond the hitting line is strictly prohibited.
- Children under 12 must have adult supervision.
- Appropriate footwear is required for all guests. No open-toed footwear is allowed.
- Do not attempt to recover balls past tee lines.
- Golf instruction is to be conducted by authorized Hiland Park Country Club instructors only.
- Range balls and buckets must not be taken from the property.
