Request for Proposal

Concrete Repair

Emery County School District is seeking proposals from qualified vendors to provide concrete replacement services. The purpose of this Request For Proposal is to identify a vendor who can meet our Concrete needs efficiently, effectively, and within budget. Interested vendors are invited to a mandatory walkthrough on **February 18, 2026**, at Castle Dale Elementary, beginning at **9:00 am**. Submitted proposals must follow the guidelines outlined below.

Scope of work:

The selected vendor will be responsible for the following:

- A. Remove and replace the concrete area extending from the sidewalk on 600 North to the school at Castle Dale Elementary. (approximately 2000 sq ft) of 4 inches thick concrete
- B. Remove and replace the concrete area extending from the playground to the walkway at Cottonwood Elementary. (approximately 2300 sf) of 4 inches thick concrete
- C. Remove and replace the concrete around the entrance doors on the east side at Canyon View Middle School. (approximately 300 sf) of 6 in thick concrete.

Proposal Guidelines:

- A. Company overview: Provide a brief introduction to your company, including its history, experience in the Concrete industry, and any relevant certifications or affiliations.
- B. Project approach: Describe your approach. Highlight any unique methodologies or technologies that set your company apart from competitors.
- C. Portfolio: Include a portfolio of previous work. Provide references from past clients who can attest to the quality of your work.
- D. Cost estimate: Provide a detailed breakdown of costs, including materials, labor, and any additional charges. Specify any potential factors that may affect the final price, such as customization requirements or extra services.
- E. Timeline: Present a proposed timeline for the project, including estimated start and completion dates. Indicate any potential constraints or dependencies that may impact the schedule.
- F. Warranty and support: Outline the warranty offered on the installed Concrete and any post-installation support or maintenance services provided.

Evaluation Criteria: Proposals will be evaluated based on the following criteria:

- A. Cost-effectiveness: competitive pricing and a transparent breakdown of costs. 40 points
- B. Experience and Expertise: Demonstrated experience in the concrete industry, particularly in commercial installations. 15 points
- C. All requirements specified in the scope of work and walkthrough are addressed, and all criteria are included. 30 points.
- D. All required documentation is submitted before the deadline. 15 points.
- E. Timeliness: The proposed timeline for completion of the project is August 1, 2026
- F. Customer References from previous clients.




