Suzanne Marie Petrucci, BS, MSW, LCSW is a Social Work Professional with more than twenty-two (22) years of experience as a Licensed Clinical Social Worker. She is licensed in the states of New Jersey and Delaware where she is qualified to evaluate, diagnose, and provide mental health treatment to children and adults. Her primary private practice out-patient location is in Woodbury, New Jersey. In response to the pandemic, she began offering telemedicine in April 2020. Her therapeutic approach is primarily oriented to the Cognitive Behavioral Therapeutic model of psychotherapy studied at the Philadelphia College of Osteopathic Medicine where she received certification in 2002. Suzanne developed "Rehearse Engineering" as a method to assist with cognitive behavioral therapy using patient selected music selections that were considered resonating. Her contribution to the field of Social Work can be reviewed through the documentary she produced, "The Olive Branch", which describes the development of this unique tool. Suzanne has a unique blend of skill sets that encompass her background working in many different settings including inpatient hospital psychiatric units, in-home settings working with at-risk youth referred by the state and supporting adults in the community suffering from psycho affective disorders as well as traumatic stress.

Suzanne worked with the Department of Defense as a Military Family Life Consultant and voluntarily deployed to three military installations between 2011 and 2015. As the owner of a private practice since 1999, Suzanne is most passionate about her interest in forensic Social Work which developed early in her career. Her experience in documenting her clinical findings for legal purposes is a rare passion that brings cases to life in a humanistic manner, written in her own unique style to capture the essence of "what happened". Trauma is more easily overcome by having a voice and an opportunity to change how the story will end. Cognitive behavioral therapy, in the same way, is a form of therapy that heals through looking at how we assign meaning to events, and then providing the opportunity to choose different ways of thinking about events that will lead to better feelings and behavior. Finding the words is the essence of much of her work.

“The Olive Branch” Documentary and Song Recording of “Find the Words”.

Suzanne produced and directed a documentary called The Olive Branch. This is a movie about a psychotherapist who closes her business doors and changes her delivery of services to telemedicine overnight as a result of the pandemic and finds that her personal singing music lessons are useful in her own stress management healing from exposure to vicarious trauma connected to her work and in the treatment of her patients as they adjust to the new normal. This documentary offers live footage of singing lessons that take place in a local church where

Suzanne is learning to sing 50 feet away from her music teacher who is interviewed in the production along with two other musical mentors. One student (patient) is featured in the film who was seeking help from Suzanne at the urging of his mother at the beginning of the pandemic when remote learning began during his senior year of high school after 14 years of attending gymnastics 20 hours per week. While his only goal was to increase his school ranking by 1 percent, he shares his story in the documentary. The documentary was created after many surprising achievements and personal breakthroughs were noted in patients who had participated in the new form of rehearse engineering music therapy that Suzanne instructed as homework assignments (Isolation Rockstar) using patient selected songs. The United States was in isolation. Suzanne produced a song called "Find the Words" and included her 3 musical mentors in the recording who play the piano, flute and guitar which accompanied her singing voice which was written from an article she wrote and published about trauma in 2020.

FORENSIC HIGHLIGHTS EXPERT WITNESS

Dog bite with a minor patient. Suzanne treated a young girl with a traumatic history of being mauled by a pit bull on her way home from school when she was 9 years old. Suzanne encouraged her parents to contract with a new attorney because the current one had not contacted her to discuss her thoughts about the case or provide a letter of representation. Suzanne researched attorneys specializing in dog bites and made the referral. Suzanne received \$5,000 for her report of the injury and treatment history and this was the highest payout for a dog bite settlement in New Jersey involving policies of two different homeowners. Suzanne's report demonstrated the role of the homeowners as well as their relative owner of the visiting dog who was the responsibility of the homeowners at the time the dog bite occurred. The patient contacted Suzanne during the pandemic to resume counseling after nearly five years after being discharged and continues to work with her today while at college. The patient received \$525,000 for her settlement.

Suzanne coordinated a **Fitness for Duty** exam with a local medical doctor for a police officer who drove 23 hours from Kansas to be evaluated. The officer had been fired for suspected drunk driving, when his car was abandoned on the road one mile from his house early in the morning. The officer was made to take jobs and work with criminals he had arrested. An arbitrator determined that the officer was not found guilty of anything when tapes showed that his truck had been driven earlier that morning by his girlfriend, however, he was not allowed to return to driving a patrol car and was made to work only at the desk for two years leading to serious depression, which then led to his temporary leave from work with orders to return after having a favorable Fit for Duty exam. Suzanne provided this with a lengthy report of evaluation including character witness after extensive conversation using cognitive behavioral training, to understand and explain in the report how the police officer was assigning meaning to his circumstances. Today he is back in his patrol car, newly married with his first child.

Leaving the scene of an accident with fatality – Suzanne provided a ten-page report to the court for a single white male bartender who believed he had hit a deer on his way home from dinner with friends. After inspecting his vehicle in his driveway with proper lighting with the help of his roommate, he discovered signs that a human may have been hit. He returned to the scene of the accident and discovered the body unresponsive and called the police. He was taken for a legal blood draw and received a DWI after 6 months. While the judge appreciated his decision to call police to the scene, he received 9 months in jail for leaving the scene of an accident, which he did not report initially, in hopes to avoid involving his roommate. At sentencing, the patient was supported by 10 friends from AA and remains sober today.

Defamation of character – Suzanne flew to a California court room and her testimony as an expert witness was admitted into evidence as the closing witness of a seven-year trial involving 5 attorneys across 3 states. She was able to diagnose the client with PTSD and demonstrated her evaluation and findings were supported by a former psychologist at Harvard Medical School and the patient's primary care physician. Suzanne had reviewed

7 years of depositions, recorded phone calls, family medical records, and the patient's previous work history and scheduled payout bonuses documented in his offer letter and previous performance review with Human Resources at a pharmaceutical company and was able to show that the patient's mental health deteriorated after the defendant filed fraudulent charges (protection from abuse) which prevented the patient from caring for his mother and managing the family estate. Suzanne oriented the court to the detailed nature of the covert campaign that led to her client's alienation from the family, resulting in mental health decompensation, excessive alcohol usage, job loss and legal expenses of 250K. The client was prevented from caring for his mother who had been recently diagnosed with dementia of the Alzheimer's type, just one day prior to the death of his father. Suzanne had accepted the assignment for a set fee of \$2200 and spent no less than 40 hours researching the case, in addition to four days in California waiting to be called as a witness. She testified without providing any reports as no new evidence was permitted at that point. Suzanne testified again one month later from Delaware via zoom. After her final testimony, Suzanne received a later complaint from the defendant (filed prior to her second testimony) claiming she was a friend of the client's wife. Suzanne provided a very thorough package to the Board of Social Work (50 pages of her work) which was accepted as she demonstrated she had sought consultation prior to taking the case, and her paper trail demonstrated she conducted herself in a professional manner and had extensive clinical details, receipts for appropriate fees processed, and excellent transparency which was accepted by the board after investigating the complaint.

Workman's Compensation/Social Security Disability/Personal injury (PTSD) after NJ Bank robbery – Suzanne Evaluated a bank employee who felt she could no longer return to work after managing a traumatizing bank robbery with physical abuse and false imprisonment. The employee said she could not even drive her car past the exit to the bank. The robbery took place the day that the robber was released from prison after serving five years for robbing the same bank. After the evaluation, Suzanne was not authorized to treat the patient who was assigned to work with 4 different psychologists over the next three years, however, Suzanne was willing to work with the employee as an ongoing evaluator for private pay which the patient agreed to. Suzanne supported the patient throughout the three-year treatment period, providing clinical reports and completing forms which were approved for short term disability, long term disability, and finally social security disability. After the employee's last day of work at the bank, the bank provided a temporary security guard for only two weeks and the day after the guard was dismissed, the patient was taken to the emergency room by her 72 year-old mother, where she was evaluated and treated for a panic attack. The following day, the patient watched the news only to learn that the bank had been robbed again, only this time masked men had jumped the counter holding guns to the heads of her former coworkers/employees. The employee had been working at that position for over 20 years and endured sarcastic discussions from multiple professionals who attempted to bully her into walking into a competing bank during a snowstorm to open a bank account, in order to show her (a form of exposure therapy) that she would be safe to return to work. A psychologist who was part of the risk management company misled the patient, stating that he had spoken with Suzanne and that Suzanne was "on board" with the approach. Suzanne contacted the psychologist and "called him out about lying to her patient" and his mal-practice ways, and the patient was no longer bullied by anyone. The patient has not missed a day's pay in five years, and is awaiting settlement while on permanent disability. Suzanne's report to the social security administration was informative and pointed out that the risk management company refused to provide even one psychiatric evaluation to the patient, however, they were willing to pay for medication prescribed by her family doctor. Although four psychologists treated the patient, not one of them was willing to write a formal professional report using the industry standard assessment for the diagnosis of PTSD for her social security hearing. Suzanne provided 220 pages of detailed notes and a comprehensive 15-page report along with testing demonstrating the patient was suffering from Post-Traumatic Stress Disorder and her permanent disability was approved.

COPARENTING AND CUSTODY

Suzanne has participated as an expert witness in numerous court cases over the last decade. Special areas of interest include guardianship, supervision, substance abuse, child support and parental responsibility in funding college expenses. Suzanne has extensive experience working with clients and legal professionals in the navigation of coparenting, recognizing parent alienation, reunification therapy and understanding the significance of a secure base and how that relates to attachment styles throughout the lifespan.
