If a candidate is on a payment arrangement with Murray Irrigation, they are considered to be financial. This also applies to a body corporate, if the candidate is an authorised representative of the body corporate.

Candidates who are nominating as an authorised representative of a corporation that is a shareholder of Murray Irrigation must also complete and lodge a Form 18 'Authorised Corporate Representative' form, available on our website www.murrayirrigation.com.au from the *Member Director Nominations* page or from the *Forms* section, with their nomination form.

All candidates will be required to undertake a national police check and provide a copy of their National Police Certificate with their nomination form. A national police check can be undertaken through the Services NSW website at https://www.service.nsw.gov.au/transaction/apply-for-a-national-police-check. Alternatively, Murray Irrigation will accept a copy of a National Police Check previously obtained by the candidate provided it is dated *no earlier than 1 January 2025*.

Candidates may provide a statement of no more than one (1) A4 page (no more than 450 words) supporting their nomination with their nomination form. This statement will be provided to shareholders in the event of an election.
