Tournament Rules

1. The GSA Handicap Women's Championship will observe all USBC playing rules in regards to competition and equipment.
2. **Eligibility:** All Participants must be an active GSA 2023-2024 member in good standing prior to the tournament
3. **Dress Code:** All clothing must be neat, clean and in condition. **No** inappropriate advertisements will be allowed on any attire or equipment. Jeans, slacks, walking shorts, Capri pants, skirts are permitted. **No** tank tops, halter tops, spaghetti strips, sweats, gym shorts or cut-offs of any kind.
4. **Average:** Entrants will use their highest 2022-2023 fall/winter season average of at least 21 games. If none, entrants must provide a league standing sheet from the current season of at least 21 games. If neither the entrant will enter at 230.
5. **Handicap:** Handicap will be 90% of 230 per bowler.
6. **Format:** Bowlers will bowl 4 games moving one pair to the right after each game. Top 5 qualifiers will bowl in the stepladder finals single game elimination. To determine Women's Champion
7. **Awards:** A ratio of 1 in 6 will be used for all awards
8. **Conduct:** Good sportsmanship is required by all participants. Any unsporting behavior will be addressed by the tournament committee and may result in a warning or disqualification.
9. Only bowlers or tournament officials are allowed in the settee area. No food or drink allowed in the settee area. No powdery products (Easy slide, Baby powder) may be applied to bowling shoes at any time.
10. Protests/Appeals: the Greater Sacramento Area USBC office must receive any protest or appeal within 72 hours of the in fraction.
11. **A \$35.00 service fee will be charged for any returned checks. Day of tournament CASH only**
