

ORDINANCE 2544

AN ORDINANCE VACATING THE ALLEY BETWEEN INLOT NUMBERS 446, 447, 454 AND 455, WITHIN THE VILLAGE OF LEIPSIC, PUTNAM COUNTY, OHIO.

WHEREAS, on the 17th day of November, 2008, a petition by The Roman Catholic Diocese of Toledo , owners of Inlot Numbers 446, 447, 454, and 455 within the Village of Leipsic, Putnam County, Ohio, was filed and duly presented to the Village Council praying that the alley located between said Inlots be vacated; and

WHEREAS, no notice of pendency of said petition and said vacation proceedings is or was necessary since the said petitioners are the sole owners of said Inlots 446, 447, 454 and 455; and,

WHEREAS, Council, upon hearing and consideration of said petition and the fact, is satisfied that there is good cause for vacation as prayed for, that it will not be detrimental to the general interest, and ought to be made,.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Leipsic, Putnam County, Ohio that:

Section 1. That the alley between Inlot Numbers 446, 447, 454 and 455 and within the Village of Leipsic be and the same is hereby vacated.

Section 2. All utility easements, right-a-ways and any and all other existing licenses concerning sewers, waterlines, conduits and pipelines of all kinds owned and operated by the Village of Leipsic or other public utilities shall be reserved to the Village and other utility companies with the rights of repair, construction and or replacement and maintenance.

Section 3. That a certified copy of the Ordinance shall be recorded with the Recorder of Putnam County, Ohio.

Section 4. That this Ordinance shall be and remain in force from and after the earliest period allowed by law.

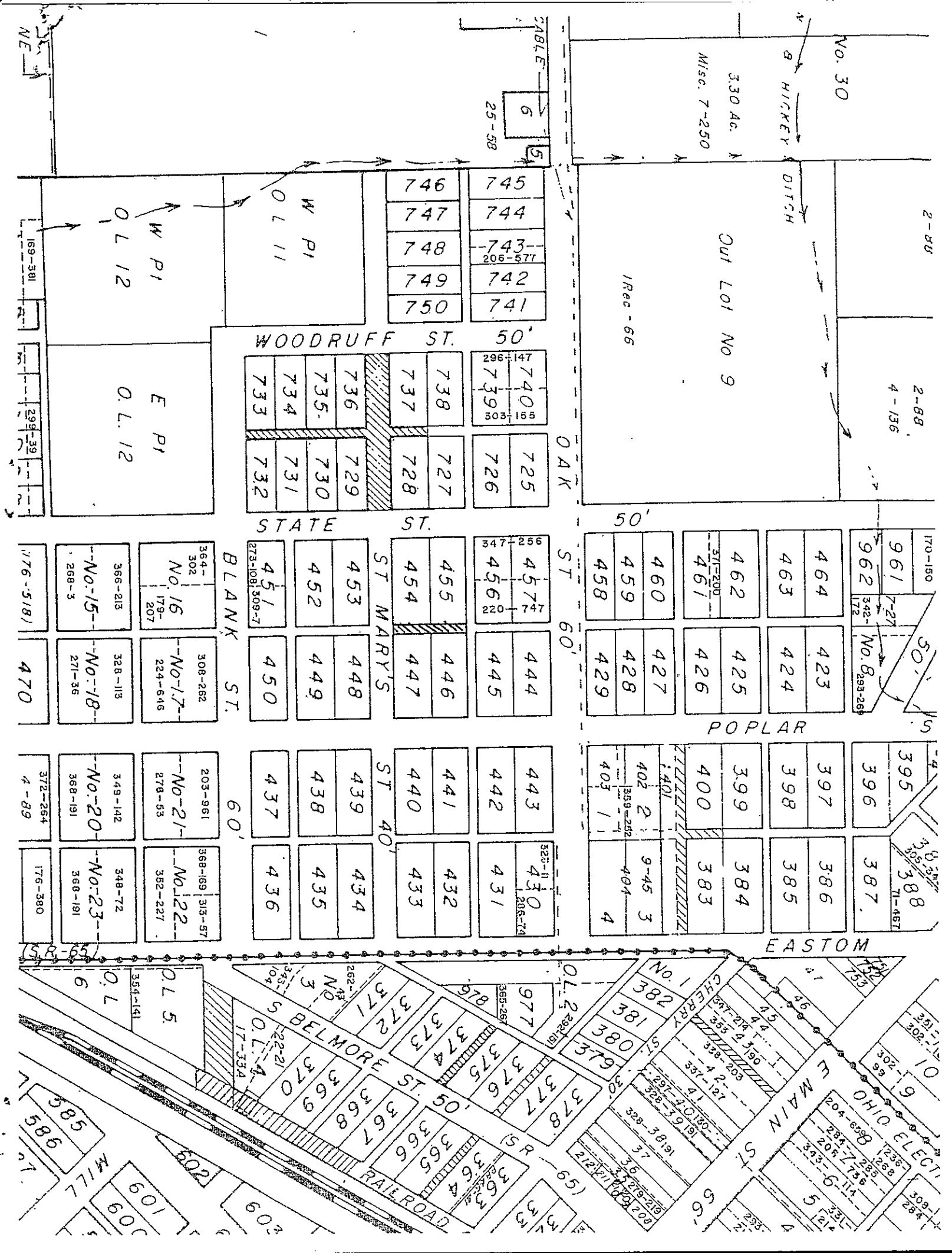

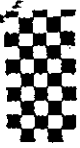
