ORDINANCE 3353

AN ORDINANCE AMENDING ORDINANCE NO. 3298 ESTABLISHING RATES TO BE CHARGED FOR WASTEWATER SERVICE FOR THE VILLAGE OF LEIPSIC, OHIO

WHEREAS, the Village Council has established rules and regulations governing the operation of and providing for the discharge of wastewater into the storm and sanitary sewage system (the "system") of the Village and has established rates and charges for the service of that system pursuant to Ordinance No. 2583, passed June 15, 2009; and

WHEREAS, the Village Council has determined that an increase in the user charge for the Village of Leipsic's wastewater treatment system is required to meet its cost of operation increase; and

WHEREAS, this Council has determined it to be necessary to revise the user charge to cover the said increase costs of operation.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Leipsic, Putnam County, Ohio that:

Section 1. Section 1 of the current waste water ordinance, as it was passed, be in the same as hereby amended to read as follows:

Section 1. Section 6 (b) of Ordinance No. 2890, passed December 21, 2015, as it was passed, be in the same as hereby amended to read as follows:

SECTION 6 (b)-Sewer Service Rates

The Sewer service charge effective for December 2023 Collections for all users except Industrial Users shall consist of a readiness to serve charge of \$54.67 for Industrial Users and \$49.90 for all other users which includes 400 cubic feet. Each additional cubic feet of use will be billed at the rate of \$5.03 for Industrial Users and \$4.03 for all other Users. This will be the rate charged by the Village of Leipsic utility for users in Leipsic and West Leipsic. Users in West Leipsic will pay additional fees as established by West Leipsic.

A 50% surcharge for users located outside either Village shall be added to the monthly readiness to serve charge. Effective for December 2023 Collections users outside of Leipsic and West Leipsic, the minimum monthly charge for users will be \$81.19 for outside industrial users and \$74.10 for all other outside users and will include 400 cubic feet, additional 100 cubic feet for users outside of corporation limits will be billed at a rate of \$5.03 for Industrial Users and \$4.03 for all other Users

Section 2. This Council finds and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public on compliance with the law.

Section 3. This Ordinance shall take effect from and after the earliest period allowed by law.
