1. Sealed bids for the furnishing of the necessary materials and construction of

2026 LEIPSIC STREET IMPROVEMENTS

and at that time and place the bids will be publicly opened and read aloud.

2. The proposed work consists of approximately 262 CY of Asphalt Concrete Road Resurfacing, 2,153 SY of Pavement Planning and 44 CY of Aggregate Shoulder on Mathias Street.
3. Engineer's Base Bid Cost Estimate is \$115,000.00.
4. The work shall be substantially completed on or before **August 21, 2026**, and ready for final payment in accordance with Paragraph 14.07 of the General Conditions on or before **August 28, 2026**.
