### **Graduate Leadership Scholarship (\$10,000)**

Created to support the promotion and development of the human services sector's workforce, the Graduate Leadership Scholarship is a one-time award of \$10,000 for a Council member employee who is entering or currently enrolled in a graduate degree program.

Most accredited graduate programs are eligible provided the applicant demonstrates in their personal statement how the program is clearly related to their future contributions to the human services sector.

### **Matava and Weekes Scholarships (\$5,000)**

*(Formerly titled the Master of Public Administration Scholarships)*

The Providers' Council, in partnership with Suffolk University, will be awarding **two** Master of Public Administration scholarships. These scholarships are based on leadership, merit and financial need.

These are one-time grants of \$5,000 and will be awarded to two Council member employees who are entering or currently enrolled in the MPA program at Suffolk University.

Eligible applicants must have successfully completed the Council's Certificate in Nonprofit Human Services Management Program within the past seven years.
