SECTION 1. On the 15th day of February, 1989, the Marion County Quorum Court Enacted Ordinance No. 89-5 to amend 1989 Budget Projected Revenue and added account to Projected Revenues Summary - Boat Safety and State Aid.

SECTION 2. Currently fund Boat Safety (Emergency)-Boat Safety (3019-0400) is being overseen by the County Sheriff and The County Sheriff does not patrol waterways within the county.

SECTION 3. The County has an established emergency rescue service overseen by the Marion County Office of Emergency Management (OEM). 

AMENDMENT TO ORDINANCE 2022-44 AN ORDINANCE AMENDING THE ANNUAL
OPERATING BUDGET AND NUMBERS AND COMPENSATION ORDINANCE 2021-124 AND
ORDINANCE 2022-13, TO APPROPRIATE FUNDS FROM AMERICAN RESCUE FUND (3046)
TO AMERICAN RESCUE FUND FIRE DEPARTMENTS FUND (3046-0502). THE TOTAL
AMOUNT WILL BE \$170,105.30.

SECTION 1. Affirmation. This Court affirms that purchase of equipment and moving of radio
towers for county fire department services is a recommended use of ARPA funding in
accordance with the Final rule issued by the U.S. Treasury; and that this equipment is vital in
the ongoing Covid pandemic. Therefore, this Court declares that the purchase of equipment
and moving of towers to enhance coverage for the fire department radios to be used fire
department services be budgeted as set forth in this ordinance.

SECTION 2. Emergency Services. The purchase of new equipment and relocation of fire
department radio towers is needed to replace equipment that is out of date, frequently
inoperable, and unable to be updated. Replacement of radio tower equipment and relocation of
towers is vital to the day to day operations and with the ongoing Covid pandemic.

AN APPROPRIATION ORDINANCE AMENDING THE ANNUAL OPERATING BUDGET AND NUMBERS AND COMPENSATION ORDINANCE 2021-124 AND ORDINANCE 2022-13 FOR CALENDAR YEAR 2022 FOR MARION COUNTY, ARKANSAS; TO APPROPRIATE PREMIUM PAY FOR MARION COUNTY EMPLOYEES FROM ARPA FUNDING CONVERTED TO REVENUE REPLACEMENT FUNDS.

Article 1. Affirmation. This Court affirms that Premium Pay is a recommended use of ARPA funding and may be paid retroactive to January 1, 2021 in accordance with the Final rule issued by the U.S. Treasury; and that "premium pay" may be provided to eligible workers that are performing essential work in person. It is further recognized that all Marion County employees are eligible for premium pay in that the Final Rule confirms that "any work performed by an employee of county government involving regular in-person interactions or regular handling of items also handled by others" is premium pay eligible. This Court affirms that the Marion County Courthouse and other county buildings and operations remained open for business during the ongoing Covid pandemic and employees worked "in person: and not remotely. Therefore, this Court declares that premium pay be budgeted and paid to Marion County employees as set forth in this ordinance.

Article 2. Premium Pay. Premium Pay for Marion County employees will be a one-time lump sum payment and will not be incorporated into the base pay of an employee for future salary adjustments. Premium pay is subject to all applicable employee payroll deductions. Premium pay is set at \$2.00 per hours worked in 2021 for a full-time employee that has been employed full-time with Marion County from January 1, 2021 – December 31, 2021 and has remained employed up to and as of the date that premium pay is issued. Any county employee working part-time or hired after January 21, 2021 will be paid a prorated amount as calculated by the Comptroller's office as long as they are currently in the same status as in 2021. To receive premium pay a person must be currently employed by Marion County. The calculation of all premium pay shall be filed in the office of the County Clerk and there kept for public use, inspection, and examination pursuant to § 14-14-907(b).
