BE IT ENACTED BY THE QUORUM COURT OF MARION COUNTY, ARKANSAS, AN ORDINANCE TO BE D. ENTITLED:

AN ORDINANCE TO REVISE THE ANNUAL COMPENSATION OF COUNTY ELECTED OFFICIALS AND AMEND ORDINANCE 2024-61, THE 2025 ANNUAL OPERATING BUDGET AND NUMBERS AND COMPENSATION ORDINANCE FOR MARION COUNTY, ARKANSAS.

<u>SECTION 1.</u> This amendment is for budget increases for Marion County elected officials pursuant to the Marion County Budget and Numbers and Compensation Ordinance 2024-61.

<u>SECTION 2.</u> A.C.A. 14-14-1204 requires a 3% annual cost of living adjustment to approved salary ranges for County elected officials. No increases have been budgeted by the Marion County Quorum Court since Ordinance 2014-16 dated March 13, 2014, except as required to comply with mandated minimums when salaries fell below the acceptable range.

<u>SECTION 3.</u> This amendment will increase the current budget appropriations by 25% for elected officials' salaries to historically align with ACA 14-14-1204 and will modify the existing numbers and compensation schedule for the remainder of the calendar year of 2025 as follows:
