AN ORDINANCE AMENDING THE ANNUAL OPERATING BUDGET AND NUMBERS AND COMPENSATION, ORDINANCE 2023-149 FOR CALENDAR YEAR 2024 FOR MARION COUNTY, ARKANSAS TO TRANSFER FUNDS FOR UNCLAIMED PROPERTY BACK TO THE MARION COUNTY SHERIFF'S OFFICE.
