TRANSFER UNAPPROPRIATED FUNDS TO 1000 COUNTY GENERAL FROM 2000 COUNTY ROAD FUND FOR 50% REIMBURSEMENT OF ORD 2025.40 (THE TWO-MILE PREP/PAVING OF MC 8001).

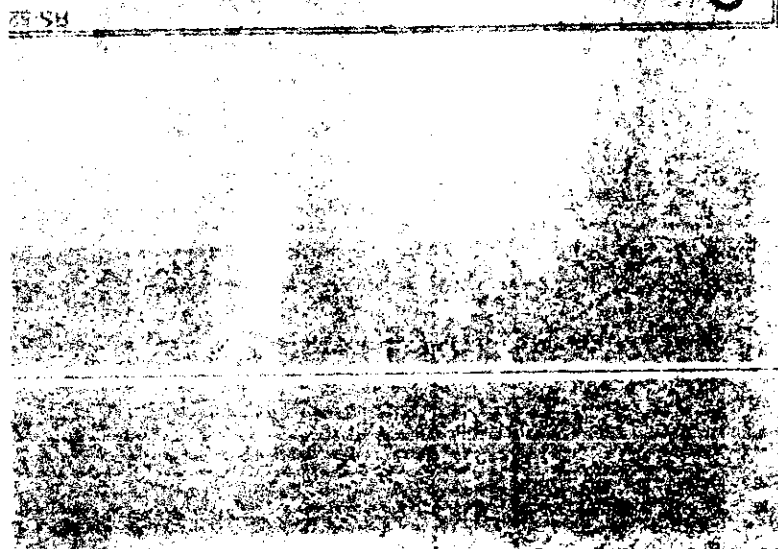
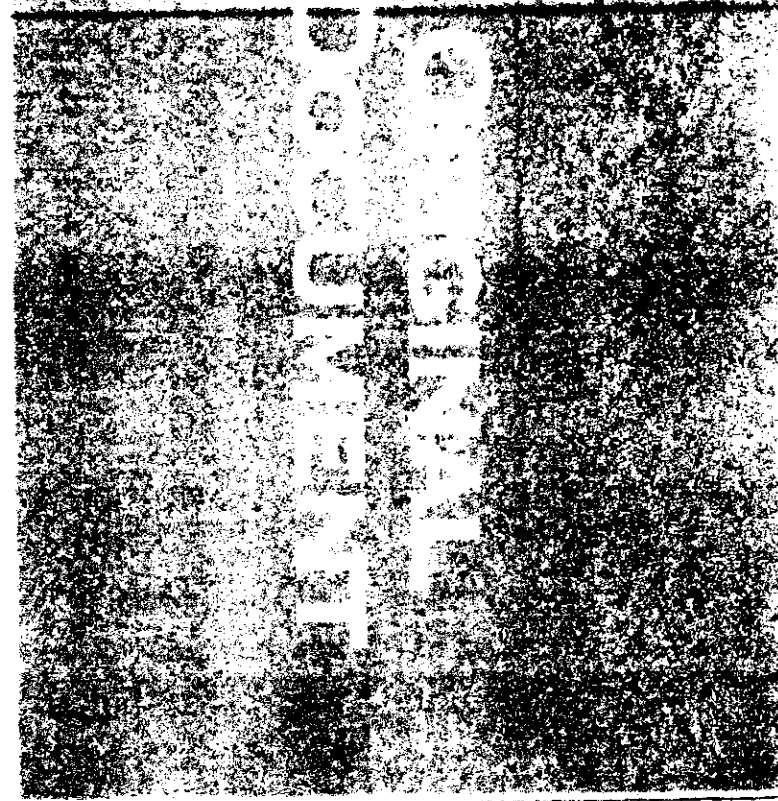
