MARION COUNTY QUORUM COURT MINUTES

January 10, 2023

The Marion County Quorum Court held their monthly meeting beginning at 6 p.m.

Judge Stumph presided over the meeting and all Justices were present. Justice Hutching gave the invocation and Justice Reed led the pledge.

All reports were read and accepted. During the Treasurer's Report, Treasurer Susann Crespino stated that she did not have any confidence in the numbers that her reports were generating and that she had a call into the software company for assistance in this matter. The Law Enforcement report was made vocally by Sheriff Gregg Alexander. He stated that the old vehicles were in the process of being stripped by the 309 inmates. He continued to state that he anticipated that sometime in February those vehicles would be disposed of. Justice Scrima stated that he has asked several times for a report that showed which vehicles were assigned to which officer. He also requested an updated report of the current inventory for the Sheriff's office. There was no vote on the library report as no one representing the library was in attendance. Sandy Evans, secretary to the Fire Board, announced that the towers were up and they were waiting for the licenses, and hope to have the tower up and running by February.

Justice Vancuren made the motion to read the ordinance by title only. Justice Nicekls seconded the motion and the motion passed unanimously.

Judge Stumph had requested that a procedural ordinance that he prepared be placed on the agenda for this meeting. He did not have any sponsored for said ordinance. Justice Hutching agreed to sponsor the ordinance, but the current procedural ordinance states that after the packets are sent out, three Justices must sponsor an ordinance in order for it to be placed on the agenda. Therefore, this ordinance was not presented.

Ordinance 2023-1 – Procedural Ordinance – Sponsored by Justices Vancuren, Brigham, White, and Scrima. This ordinance outlines the Procedural guidelines for the Quorum Court for each meeting. The motion to adopt was made by Justice Vancuren and seconded by Justice Brigham. During the discussion, Justice Scrima suggested that the court go through this ordinance carefully to make sure everyone understood what the proper procedures were. Judge Stumph, in the ordinance he had presented had requested a change in the time and date of the regular meeting. He stated that he had gotten some feedback from citizens that changing the meeting time to 4 p.m. was beneficial to some people so that they did not have to

go home and come back at 5:30. Justices McCalla, Scrima, and Brigham all stated that they had spoken to some of their constituents and overwhelmingly they wanted the time and date to remain the same. Justice Hutching offered that the Librarian had stated that someone would be there to give the report if the meeting was during the day. Another point of discussion was that if the elected official cannot attend a meeting and has an ordinance before the court, the proposed ordinance would be tabled until the next meeting. Also, addressed was that the public has the opportunity to voice their opinion of any ordinance before the court as a whole votes on said ordinance. However, their Justice must be a sponsor to the ordinance and the person requesting the time to address the court must be on the agenda. Clerk Dawn Moffet asked if this ordinance can be amended. She would like to see that there be a deadline as to when reports and ordinances can be placed on the agenda. She will present an ordinance to the procedural committee at their next meeting to reflect this change. The motion to adopt passed unanimously.

Linda McKeon representing the Oakland Community was advised to make an appointment with Sheriff Alexander and if necessary ask to be placed on the February agenda.

Justice White was nominated by Justice Scrima to be the delegate to the Arkansas Association of Quorum Courts. Justice Brigham seconded and the motion passed unanimously. (Clerk's note: Wednesday, January 11, 2023. Justice White contacted the Clerk and stated that Justice Hutching would like to be the delegate. Justice White stated that he thought that a newly elected Justice would benefit more from this meeting. He also stated that he would be contact the other Justices to let them know of this change.)

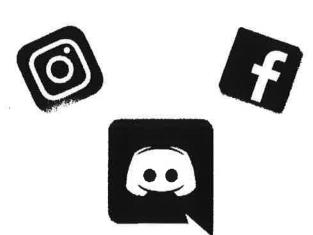

New Business:

- 1. Nomination of committee chairman and secretary
 - a. Justice Hutching was nominated as Committee Chairman,
 - b. Justice Reed was nominated as Committee Secretary.
- 2. Consideration of a complete review of the current Personnel Manual.
 - a. Justice Reed commented that he had several recommendations for several changes/questions concerning certain statements.
 - b. Mr. Russo also commented that he wanted to make a complete review of the Manual and submit recommendations at a later date.
 - c. Alicia Owens, of the Library Board submitted the Library Board Telework Policy for Committee review.
 - i. Justice Bergman suggested that the Library Telework Policy be considered for inclusion in the Personnel Manual.
 - ii. Mr. Russo recommended that a Telework Policy should be county wide.
 - iii. Justice Bergman commended that no telework should be allowed county wide until such policy is included in the Personnel Manual. Note: This was adopted as a recommendation to the Quorum Court.
 - d. The Personnel Manual review was tabled.
- 3. An Ordinance to Amend Ordinance 2018-44, the Marion County Personnel Policy
 - a. Proposed amendment to Paragraph 6, Hiring and Promotion

Existing Section 6 paragraph 2, "Effective upon passage of this Ordinance (2018-44) employees rehired after separation from employment shall be treated as new employee."

Proposed change Section 6 paragraph 2, , "Effective upon passage of this Ordinance (2018-44) employees rehired after more than a six (6) month separation from employment shall be treated as new employee."

Deliberation:

Justice Bergman took exception to the 6 months of separation commending that she believed this to be an unreasonable length of separation and recommended a 90 day separation was more realistic.

The Committee agreed

Actions:

Modify the proposed ordinance to replace the phrase "six (6) months" with the phrase "90 days."

Submit the modified Ordinance to the Quorum Court.

- 4. Review of a Policy Statement for Marion County Sheriff
 - a. The policy defined the line of succession for the Sheriff's office.
 - b. Justice McCalla recommended a review of the line of succession for the Sheriff and the Judge. The issue was redundancy as the same name appeared in both lines of succession.

Deliberation:

Mr. Russo commented that redundancy was acceptable

Action:

Submit the policy modification to the Quorum Court.

- 5. Justice Reed suggested that a review of the county's information security practices would be reviewed and an Information Security Plan to be developed.
- 6. Sheriff Alexander submitted a need for four (4) new jailer positions

Deliberation:

Sheriff Alexander shared his concern that the State would find that the inmate to jailer ratio would be a deficiency. He expected a review of this ratio by the state in the near term.

Actions:

The committee agreed to the need,

The committee submitted the Sheriff's request to the Budget Committee.

7. Sheriff Alexander submitted a need for a Jail Administrative Assistant

Deliberation:

After some discussion it was determined that this was not a new poison but a promotion within the Sheriff's office

Action:

The Sheriff withdrew the submittal

8. Sheriff Alexander submitted a need a Bailiff/Warrant Officer and Sex Offender Deputy

Deliberation:

The Sheriff submitted a position description that encompassed the functions of Court Bailiff, Warrant Officer and Sex Offender Deputy

After some discussions the position was agreed to as an essential Sheriff function.

Action:

The committee agreed to the need.

The committee submitted the Sheriff's request to the Budget Committee.

9. Sheriff Alexander submitted a need a Bailiff an Assistant Jail Administrator

Deliberation:

The Sheriff commended that the administration of jail records was not being completed in a timely manner due to this staff shortage. He stated that certain state reimbursement request had not been submitted until late in 2022 and that approximately \$30,000 was not received until recently.

After some discussions the position was agreed to as an essential Sheriff function.

Action:

The committee agreed to the need.

The committee submitted the Sheriff's request to the Budget Committee.

10. Sheriff Alexander submitted a need a for a comprehensive inmate Health Care program.

Deliberation:

The Sheriff commended that the current inmate Health Care Program did meet state standards and was inadequate opening the County to possible law suites

Mr. Russo shared his experiences with law suits regarding poor inmate health care programs.

The Sheriff shared that the current Nurse that implement the present program is responding to 11 different law suits

The Sheriff commented that the County no longer has inmate liability coverage as the Association of Arkansas Counties dropped liability coverage for counties as of December 31, 2022.

After some discussions the proposal was agreed to as an essential Sheriff function.

Action:

The committee agreed to the need.

The committee submitted the Sheriff's request to the Budget Committee.

Law Enforcement Committee Meeting January 19, 2023

The first Law Enforcement Committee meeting was held in the Annex and began at 5pm. Members of the committee attending were Justice John Reed and Justice Joyce McCalla. Justice Marty Nickels was unable to attend.

The first order of business was selecting the chairman and secretary. The chairman is Justice McCalla and the secretary is Justice Nickels. In Justice Nickels absence, Justice McCalla is providing the minutes for the meeting.

The meeting was taped by Robert Lyons, VA
Representative for the county as the normal tape
recorder was not charged.

Next, five citizens from the Oakland Community, Mike & Linda McKeon, Mike & Misty Treat and Justice Mike Scrima, addressed the committee with concerns regarding the increase in crime in their community. They have talked with Sheriff Alexander and hopefully this can be remedied. The community has set up a Neighborhood

Watch program along with encouraging residents to lock up buildings and houses, record serial numbers and install security or game cameras. They wanted to announce and invite everyone to their Valentine's Dinner to be held on February 11th at the community center. The menu will include spaghetti with traditional sauce and spaghetti alfredo. Time is 5pm-7pm.

Next, Sheriff Alexander presented the following ordinances for discussion:

- 1. The need for vehicles. Ordinance submitted asks for 7 vehicles to be paid for with American Rescue Fund in the total amount of \$348,922.00. This had been previously discussed at the 12/22 meeting. The main concern is if we buy all 7 at one time we will not have the money to buy 7 at one time in the future. There was discussion regarding this and Sheriff Alexander stated he would submit as is at the upcoming budget meeting.
 - 2. The need for medical care for the inmates.

 Beginning 01/01/23 the AAC quit paying for part of the healthcare which was costing us \$3000.00 per month in addition to what AAC was paying. Sheriff Alexander has obtained 3 bids along with contract renewal. The problem with the renewal is they have

been and are involved in lawsuits and we do not need to take a chance on this. Turn Key Health was selected as the lowest bid and they are already taking care of inmates in some areas of the state. Medical Healthcare is required by standards.

- 3. Ordinance to create line item for the Christmas Shop with a Cop. We currently have \$4500 which needs to be appropriated in Line Item 3568. Since this line item had not been created \$1128.00 was paid out of general supplies for Shop with a Cop and this needs to be corrected.
 - 4. Ordinance to hire 4 jailer positions. This had been discussed also at the 12/23 meeting.
- 5. Sheriff Alexander is requesting to hire a chief deputy and bailiff. The committee gave him the okay to

write the ordinance.
The committee was concerned as to how this would be paid for and Sheriff Alexander stated none of the money would come from county general. The revenue from the jail should pay for the majority and Judge Stumph has agreed to transfer 3% of the sales tax received for his department to the Sheriff. This is anticipated to be approximately \$3000.00 per month. Sheriff Alexander also asked for the PILT money the county received of

\$299,000.00. The money can be spent for Law Enforcement among other items. This will need to be discussed. Sheriff Alexander stated the state inmate check for January was \$30,000.00. Also, a previous month in 2021 had not been billed but has been now and the amount was \$21,000. Also, they are turning in reimbursements for medicine they previously bought. It was noted that this all depends on revenue from inmates and what happened when we did not have the revenue. Sheriff Alexander says if we can not pay positions, they will be unemployed.

Meeting adjourned at 7pm.

BE IT ENACTED BY THE QUOURM COURT OF THE COUNTY OF MARION, STATE OF ARKANSAS, AN EMERGENCY ORDINANCE OT BE ENTITLED:

AN ORDINANCE ESTABLISHING PROCEDURES FOR THE MARION COUNTY QUORUM COURT FOR FISCAL YEARS 2023 AND 2024.

Whereas, the Marion County Quorum Court is required by Arkansas Code Annotated 14-14-904 to determine its rules of procedure in order to properly conduct the business of county government.

NOW, THEREFORE, BE IF ORDAINED BY THE QUOURM COURT OF MARION COUNTY, ARKANSAS THAT:

Section 1.

A The Quorum Court of Marion County, Arkansas adopts in its entirety the rules of procedure as stated in the Procedural Guide for Arkansas County Quorum Court Meetings, published by the Association of Arkansas Counties. In those instances where this guide does not explicitly address the situation, Robert's Rules of Order Newly Revised (RONR) shall be the standard procedural guide for all meetings.

Section 2. Meeting Dates

- A. (1) The regular monthly meetings of the Marion County Quorum Court shall be held on the second Tuesday of each month, beginning at 6 p.m., in the 2nd floor courtroom of the Marion County Courthouse.
- (2) If the date of the regular meeting falls on a holiday, the County Judge is authorized and empowered to choose another date for the Quorum Court to meet. The County Judge shall notify the County Clerk of the date, and the County Clerk shall notify all members of the Quorum Court not less than four (4) days prior to the new meeting date.
- **B.** (1) The County Judge or a majority of the elected Justices of the Peace may call Special Meetings upon at least twenty-four (24) hour notice. The notice of said meeting shall specify the Subjects, Date, Time and Designated Location of the special meeting. Only such business as was included in the notice may be considered.
- (2) All special meetings of the Quorum Court and any of its committees shall be in conformance with the Arkansas Freedom of Information Act and all other Arkansas State laws.

Section 3. Order of Business

A The following order of business shall apply to regular and special called meetings of the Ouorum Court.

- 1. Call to Order and Roll Call
- 2. Invocation and Pledge of Allegiance
- 3. Disposition of Minutes from Previous Meeting

- 4. Committee Reports
- 5. Unfinished Business
- 6. New Business
- 7. Comments/Questions from the Public

Any individual may be recognized by the presiding officer for comment, however, an individual shall not have more than three (3) minutes to speak on any one issue. If a member of the Quorum Court asks a question of an individual who has been recognized for comment, that individual shall have not more than one (1) minute to respond. A two-thirds vote of the total membership of the Quorum Court shall be required to override this rule.

- 8. Announcements
- 9. Adjournment

B The office of the County Clerk shall distribute, via electronic or US Mail, the Quorum Court agenda and supporting documentation at least seven (7) days prior to the Quorum Court meeting. Any reports, Ordinances or other documents needing to be presented to the Justices must be turned in to the Clerk's office no later than 3:30 p.m. seven (7) days priors to the meeting.

C Three (3) members of the Quorum Court may submit items after the agenda closes, if it is considered to be in the best interest of the county or that important.

D The ordinance shall have the Elected Official Name(s) on the Ordinance, who it effects, and, the name(s) of 3 Justice(s) or the committee sponsoring the ordinance to be submitted for passage.

E. If the ordinance being presented increases the annual budget for the elected official(s) the Elected Official or their delegate shall give a presentation on the proposed ordinance. The presentation shall include the need and justification for the Ordinance, the estimated cost and the annual reoccurring cost. The presentation shall also include where the funds will come from to complete the project.

Note: If the elected official, or their delegate, for whatever reason cannot attend the meeting the proposed ordinance shall be tabled until the next scheduled Quorum Court meeting.

F. Public input prior to the vote of an ordinance.

The public shall be allowed their input prior to a vote on any ordinance being presented providing:

- 1. They have the JP in their district as a sponsor.
- 2. They are on the agenda to speak on this issue.
- 3. They will be allowed 5 minutes to present their views at the Quorum Court or Committee meetings.

Section 4. Committee Appointments

A The following standing committees have been established and are to be comprised of at least three (3) members and not to exceed five (5) members each.

- 1. Budget Committee
- 2. Law Enforcement Committee
- 3. Personnel Committee
- 4. Solid Waste Committee
- 5. Procedure Management Committee

B The County Judge shall appoint members to the standing committees and to the ad hoc committees from the members of the Quorum Court. Appointments shall be made at the beginning of the Quorums Court's new term and before the February meeting of that term.

Section 5. Per Diem

A All Justices of the Peace of the Quorum Court shall receive a per diem of \$250.00 for each regular scheduled meeting and any special meeting.

B All Justices of the Peace who attend their assigned committee meetings shall receive a per diem of \$70.00 per meeting.

C In the event a member of the Quorum Court incurs expenses in the pursuit of official county business, he/she may request reimbursement for such expenses. To receive reimbursement, the member must submit to the County Judge the original, itemized receipts for all expenses and provide a description and explanation of the county business conducted. Approval for overnight expense reimbursement must be obtained from the County Judge in advance of the activity.

Section 6. The Rules of Decorum for the Quorum Court include:

A Members of the Quorum Court shall not use or make inappropriate, vulgar, or contemptuous words or offensive comments. Members shall maintain a civil and courteous manner and tone.

B Members of the Quorum Court shall only speak about the matter currently under consideration by the Quorum Court.

C During presentations, discussions, or debates, members of the Quorum Court shall refrain from communicating with each other, giving attention and due respect to the speaker or Quorum Court member addressing the body.

D While a member of the Quorum Court has the floor, members of the Quorum Court and members of the public shall not interrupt the speaker unless the speaker is ruled out of order.

E Justices violating any rules of decorum may be ruled out of order by the County Judge. An individual violating rules of decorum may be removed from the meeting by a majority vote of the Quorum Court or by order of the county judge.

Section 7. The Rules of Decorum for the Public include:

A Each speaker will direct comments to the members of the Quorum Court and not to any individual member or another individual present unless a question is directed to them by a member of the governing body.

B Each speaker will refrain from personal attacks and foul or abusive language and will maintain a civil and courteous manner and tone.

C Members of the audience will respect the rights of others and will not create noise or other disturbances that will disrupt or disturb the meeting.

D Language in the ordinance would establish that individuals violating any rules of decorum may be ruled out of order by the county judge. An individual violating the rules of decorum may be removed from the meeting by a majority vote of the Quorum Court or by order of the county judge.

Section 8. Sergeant-At-Arms

A The ordinance should provide for a sergeant-at-arms that would be responsible for ensuring that rules of procedure and order are not violated and for keeping order at all meetings of the Quorum Court and its committees. The sergeant-at-arms may be the Sheriff or a deputy sheriff provided by the Sheriff or, if not provided by the Sheriff, the sergeant-at-arms may be employed by the county judge to perform the functions of the position.

Section 9. Repeal

This ordinance shall repeal that part of any previous procedural ordinances with which it conflicts.

Section 10. Emergency Clause.

This ordinance shall be effective immediately upon passage by the Quorum Court.

An Ordinance Amending Ordinance 22-98 entitled the Annual Budget and Numbers and Compensation for 2023.
Whereas, by Section 14-14-1204, Ark. Code Ann., the elected officials (Judge, Sheriff, Collector, Clerk, Assessor, Treasurer and Coroner) are to receive a 3% Cost of Living wage increase. However, in the passage of Ordinance 22-98, the numbers and compensation portion was not adjusted to reflect the increase. Therefore, the following adjustments need to be made to Ordinance 22-98 retroactive to January 1, 2023.
Whereas, the Quorum Court voted on a raise for their regular meetings (Ordinance 22-100) to \$250 per meeting, as such, the numbers and compensation portion of the budget ordinance needs to be amended to reflect this change.
Whereas, the numbers and compensation portion of Ordinance 22-98 was actually a spreadsheet from Human Resources and did show the current wages for each position, however, the spreadsheet does not accurately reflect actual budget line items.
Article 1: Numbers and Compensation shall be amended as follows:
As Passed: See Exhibit 1, which is incorporated herein by reference.
As Amended: See Exhibit 2, which is incorporated herein by reference.
Article 2. This Ordinance herein enacted is an appropriation ordinance and therefore it is effective immediately.

AN ORDINANCE AMENDING THE ANNUAL OPERATING BUDGET FOR THE MARION COUNTY DETENTION CENTER, NUMBERS AND COMPENSATION ORDINANCE 2023-_____, THE ANNUAL OPERATING BUDGET FOR CALENDAR YEAR (2023) FOR MARION COUNTY, ARKANSAS

SECTION 1. This amendment is for the creation of Six (6) new positions in the Marion County Detention Center Budget including Four (4) Jailer Positions, One (1) Administrative Assistant position and One (1) Bailiff position to the existing budget.

SECTION 2. These positions are needed to safely operate the Marion County Detention Facility, maintain proper supervision and detention of inmates, and to process arrested persons in the booking process.

Article 1. Amend Section 6 Hiring and Promoting of the Marion County Personnel Policy:

As reads:

6. HIRING AND PROMOTING

The at-will employment policy applies equally to hiring and promoting. Nothing herein shall create a property right in employment, an entitlement to be hired or promoted, or an expectancy of continued employment. Nothing herein establishes grounds upon which hiring or promoting must be based.

Effective upon passage of this Ordinance (Ordinance 2018-44) employees rehired after separation from employment shall be treated as new employees. If the employee left for medical reason (personal or family) and the gap in employment is no longer than 90 days, the employee may be reinstated as if there had been no lapse at the discretion of their supervisor.

As amended:

6. HIRING AND PROMOTING

The at-will employment policy applies equally to hiring and promoting. Nothing herein shall create a property right in employment, an entitlement to be hired or promoted, or an expectancy of continued employment. Nothing herein establishes grounds upon which hiring or promoting must be based.

Effective upon passage of this Ordinance employees rehired after more than a sixty (60) day separation from employment shall be treated as new employees. If the employee left for medical reason (personal or family) and the gap in employment is less than six (6) months, the employee may be reinstated as if there had been no lapse at the discretion of their supervisor.

BE IT ENACTED BY THE QUORUM COURT OF MARION COUNTY, ARKANSAS, AN ORDINANCE TO BE ENTITLED:

AN ORDINANCE AMENDING THE ANNUAL OPERATING BUDGET AND NUMBERS AND COMPENSATION ORDINANCE 2021-124 AND ORDINANCE 2022-13 FOR CALENDAR YEAR 2022 FOR MARION COUNTY, ARKANSAS. APPROPRIATE FUNDS FOR ELECTION COMMISSIONERS TO BE PAID A PER HOURLY RATE FOR PERFORMING ELECTION-RELATED TASKS OUTSIDE A PUBLIC MEETING OR TRAINING, AND OTHR RELATED MATTERS.

WHEREAS, The State of Arkansas has mandated additional duties and responsibilities for County Election Commissioners without mandating compensation, and

WHEREAS, the Attorney General of the State of Arkansas issued Opinion No. 2016-040 on August 25, 2016 in which he opined that the term "election officials" does not apply to members of the County Board of Election Commissioner (CBEC) when it comes to pay even though Arkansas Code in 7-1-101(11) reads as follows "(11) "Election official" or "election officer" means a person who is a member of the county board of election commissioners, a person who performs election coordinator duties, a person who is a poll worker designated by a county board of election commissioners to be an election clerk, election judge, or election sheriff, or a deputy county clerk or a person assigned by a county clerk to conduct early voting;" and therefore are entitled only to statutory pay for public meetings, training of other officials, and election day unless the Quorum Court allows for an hourly rate for other election related activities; and

WHEREAS, from at least 2015 through 2021 members of the Marion County Election Commission have been paid hourly wages for preparation of elections over and above mere meetings or poll worker training in order to have open, fair and efficiently run election which included preparing the County for vote centers to make voting more accessible to citizens, and

WHEREAS, there has been a huge turnover in election commissioners in part due to the burdens placed upon them and it has been difficult for both the Democratic Party Committee of Marion County and the Republican Party Committee of Marion County to find people willing to serve pursuant to law, and

WHEREAS, the Marion County Quorum Court in 2022 refused to pay the Marion County Election Commissioners for the hundreds of extra hours they put in for the 2022 primary and general elections and the County Judge demanded return of the hourly funds paid out based in part on Attorney General Opinion 2016-040 and the County Judge further authorized with holding of any other pay until the county was "repaid", and

WHEREAS, the Marion County Quorum Court and the Marion County Election Commission want fair and open elections with responsible accounting for expenditures as it is their duties to the Citizens of Marion County and to the people of then State of Arkansas that with the agreement of the Marion County Election Commission the following provisions are adopted:

A. ACCOUNTING:

SECTION 1: As there is no elected official or department head to approve claims submitted by or on behalf of the Marion County Election Commission all claims submitted to the County for payment shall be approved by a majority of the Marion County Election Commission at a public meeting and each claim shall include the signature of at least two election commissioners.

SECTION 2: This accounting includes all pay or reimbursements sought by commission members, poll workers or other election officials as well as all other expenses of the election commission that are to be paid by the County out of the County Election Commission budget or any special fund or grant related to elections.

SECTION 3: If the election commissioners or any election official attend a meeting or workshop or other training in which they are to be reimbursed directly by the State or Federal Government for attending then no claim may be submitted or approved by the Marion County Election Commission to seek reimbursement from County funds.

B. PAYMENT FOR PUBLIC MEETINGS, ELECTION DAY AND TRAINING SESSIONS

SECTION 1: PUBLIC MEETINGS: For all public meetings called by the Marion County Election Commission Commissioners shall be paid on the following scale:

- i. 0-2 hours \$25.00 per member
- ii. 2-4 hours \$50.00 per member
- iii. Over 4 hours \$100.00 per member

SECTION 2: TRAINING SESSIONS: Whether the election Commission is attending a training session (including those sponsored by a county or private entity but still located in Arkansas) or conducting a training session pursuant to law each commissioner in attendance shall be paid \$100 per session unless reimbursement may be sought under Section A3 above.

SECTION 3: ELECTION DAY: For primary elections, general elections and run-offs from those two elections where there is 3 or more run-offs in the County or State each election Commissioner shall be paid \$300.00 for "Election Day." If there are less than 3 races then \$100 per commissioner on Election Day for run-offs. For school elections, special municipal elections or referendums the election Commissioners shall be paid \$100 for Election Day and \$50 for any run-off.

SECTION 4: MILEAGE: No mileage shall be paid to any election commissioner for attending meetings, training or Election Day if those sessions occur in Yellville or Summit. Otherwise election commissioners may submit a claim if they used their personal vehicle or their spouse's personal vehicle and shall be paid at the rate the

county reimbursed other county employees for mileage. This section does not apply if reimbursement is possible undersection A3 above and paid directly to the claimant.

C. PAYMENT FOR OTHER ELECTION RELATED MATTERS:

SECTION 1: The Quorum Court recognizes that there are times when members of the Marion County Election Commission will have to perform tasks to prepare for elections that are not practical for a public meeting such as issues that arise in early voting or preparing a vote center for an election, or addressing issues with improper billing by suppliers. Whenever it is practical the election commission should look to other election officials to handle matters and supply materials to election centers, however should members of the election commission be called to handle these tasks that are not part of the payment scheme set out in Section B1-3 above then they shall be paid at the same rate as poll workers.

SECTION 2: That each Marion County Election Commissioner shall be limited to 50 hours of paid additional work prior to election day for preferential primaries and 50 hours of paid additional work for general elections and 10 hours of paid additional work for run-offs for those elections and 10 hours of paid extra work for any school election (including run-offs) and 10 hours of paid additional work for any special municipal election or referendum.

SECTION 3: Election Commissioners are specifically excluded from claiming compensation for their own research, reading materials or preparation of matters to be presented to a County Committee or the Quorum Court UNLESS it involved gathering materials at the request of the Quorum Court or the Budget Committee nor shall Marion County Election Commissioners receive compensation for attending Quorum Court meetings.

D. 2022 MARION COUNTY ELECTION COMMISSION MEMBERS

SECTION 1: This is for appropriating of funds for the 2022 Election Commissioners to be paid an hourly rate for performing election-related tasks outside of a public meeting.

SECTION 2: That 2022 Election Commissioners hourly rate be set the same as the hourly rate for poll workers.

SECTION 3: This Ordinance is to be retroactive to January 1, 2022. That all 2022 election Commissioners who either repaid monies paid to them for hourly work or had them deducted from subsequent paychecks shall have those funds returned to them.

SECTION 4: All county employees and elected officials involved herein shall prepare all documentation necessary to effectuate the transaction described above.

SECTION 5: That once the funds are paid to the 2022 election commissioners as set out in section D3 above those commissioners shall have no further monetary claims for 2022.

E. EFFECTIVE DATE

SECTION 1: This Ordinance is herein enacted and therefore effective immediately.

SECTION 2: All ordinances or parts thereof that are in conflict with this ordinance are hereby repealed.

POLICY STATEMENT MARION COUNTY SHERIFF

POLICY ESTABLISHING EMERGENCY VACANCY LINE OF SUCCESSION FOR THE MARION COUNTY SHERIFF

I, Gregg L. Alexander, Marion County Sheriff, acting under the authority vested in me by law and pursuant to Ark. Code Ann. § 14-14-1310, do hereby order and direct as follows:

WHEREAS, Ark. Code Ann. § 14-14-1310 requires that during an emergency or circumstances that warrant a declaration of any emergency, a vacancy in the office of county sheriff due to death or disability to the degree of inability to perform the duties of office shall be temporarily filled by a policy statement of the sheriff issued prior to the incapacity of the sheriff, designating three (3) persons in succession to fill the vacancy of the office of county sheriff on an interim basis until such time as the vacancy is filled by the quorum court as provided by law or the disability of the county sheriff is abated.

THEREFORE, the line of succession for the Marion County Sheriff is hereby established in order of succession as follows:

- 1) Chief Deputy Mark Hollingsworth
- 2) Patrol Sergeant Zeb Gilley
- 3) Administrative Assistant Jacqueline Wallace

A copy of this policy statement shall be filed in the office of the Marion County Clerk and a file-marked copy shall be provided to the Marion County Quorum Court and the Director of the Arkansas Department of Emergency Management.

The Marion County Election Commission shall discuss proposals in their public meetings and vote on them prior to submitting them to the Quorum Court or the Marion County Quorum Court committees.

We, the majority of the Marion County Election Commission select *Christopher Carter* as sole representative to talk and submit proposals to the Quorum Court and its sub-committees on behalf of the Marion County Election Commission.

INTERLOCAL AGREEMENT

THIS AGREEMENT, is made pursuant to Act 430 of 1967 and Marion County Clerk
742, Chapter 5, Section 90 of the 1977 Acts of Arkansas, by and between
the County of Marion, Arkansas, (hereinafter referred to as the
county), and the City of Yellville, Arkansas, (hereinafter referred to
as the City).

WITNESSETH:

- (I) WHEREAS, the County and the City recognize their respective obligations to provide for the protection of the persons and property of their citizens; and
- (II) WHEREAS, the County and the City have limited financial resources with which to provide for such protection; and
- (III) WHEREAS, the County and the City desire to maximize revenues and the benefits the citizens derive therefrom, and to comply with the mandate of Amendment 10 of the Constitution of the State of Arkansas; and
- (IV) WHEREAS, there is a need to provide increased law enforcement services for the County and City, such as criminal investigation division for processing of felony violations; and
- (V) WHEREAS, the County and City are desirous of an Interlocal Agreement whereby the City would provide revenues to the County, which would in turn, use such revenues for the maintenance of a Metropolitan Branch of the Sheriff's Office of said County, and for elimination of the duplication of finances and personnel between the County and City; and
- (VI) WHEREAS, by entering into such Interlocal Agreement, the City and the County would thereby be able to provide increased and better coordinated law enforcement for their citizens, and effectuate a savings of revenue, thereby allowing the County and the City to comply with Amendment 10 of the Constitution of the State of Arkansas; and
- (VII) WHEREAS, acting completely in good faith, for the purpose of effectuating a savings of County and City revenues, providing greater law enforcement protection for the citizens of the County and the City, and increasing the safety and welfare for all citizens affected hereby;

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the above premises, and for the mutual obligation hereby created and the mutual benefits so derived, the parties agree as follows:

(A) The City and the County shall coordinate their efforts to provide for greater law enforcement protection, at a reduced revenue for their citizens through the

Interlocal Agreement. Unless sooner terminated, as provided for herein, this agreement shall be effective January 1st, 2023 and shall run for a period of Twenty Four (24) months thereafter. Provided however, either party may, by majority vote of its respective governing body, elect to modify, or terminate this agreement. In order for this agreement to be modified, the governing bodies of both the City and the County must so indicate by a majority vote of their respective governing bodies. If the parties shall desire to terminate this agreement, the party or parties so desiring to withdraw shall give the other party six (6) months written notification of their intent to withdraw. If either party wishes to terminate this agreement, the agreement will be terminated at the end of the six (6) months notice period. For a period within which this agreement shall exist, the governing bodies may amend said agreement as provided hereinafter in Paragraph O.

- (B) In the event of the termination of this agreement, the parties shall each receive their properties so combined hereby, whether lease, rented, purchased or borrowed. Each party shall keep a list of assets, properly and visibly identified with tags or markings with regard to ownership.
- (C) The City shall upon approval of this agreement, lease to the County and the County shall lease from the City, all municipally owned vehicles, as equipped, which are now being used by the Yellville Police Department, for the sum of one (\$1.00) dollar per year, per vehicle. The City will provide a car every three (3) years, the type of car needed shall be upon the advice and recommendation of the Sheriff, and the City shall receive a six (6) year old car back at the time the new car is delivered. The use of said vehicles and equipment should be primarily for the Metropolitan Branch. The County shall maintain all insurance costs as presently required by the City. In the event of damage to any vehicle which is in excess of any insurance coverage, or in the event that replacement of any vehicle shall become necessary, the City shall provide all revenue necessary for the repair and maintenance or replacement so required. The Metropolitan vehicles will be identified with a distinctive striping and will be used in and near the City of Yellville unless an emergency or unusual circumstances will require their use away from the City. Any significant use of Metropolitan vehicles away from the City shall be reported to the Interlocal Board by the Sheriff. The Metropolitan vehicles shall not be used for any private purpose.
- (D) The County, its officers and employees, shall not be deemed to assume any liability for intentional, negligent act of said City or of officers or employees thereof, and said City shall hold said County and its

- officers and employees harmless from and shall defend said County and its officers, employees and agents against any claim for damages resulting therefrom.
- (E) The City, its officers, employees, and agents, shall not be deemed to assume any liability for intentional, negligent or reckless acts of said County or of officers, employees, or agents thereof, and said County shall defend said City and its officers, employees and agents against any claim for damages resulting therefrom.
- (F) The composition of the Metro Branch as to the number of personnel and their positions will be approved on an annual basis by the Yellville City Council upon the advice and recommendation of the County Sheriff. The Sheriff shall make such recommendations to the City Council on or before the first scheduled Council meeting in October.
- (G) The City shall provide sufficient revenues to the County, on a monthly basis, whereby the salaries, health insurance, pension fund, workers compensation, and other reasonably necessary personnel cost are funded for the personnel which shall be in accordance with the overall pay scale of the Sheriff's Department in such a way that there would be no salary advantage or disadvantage for personnel of the Metropolitan Branch. Metropolitan personnel will not be transferred to the County without being replaced. If a deputy resigns, is terminated or for any other reason leaves the Sheriff's Department, any training that is required to replace that deputy will be paid by the City if the slot to be filled is in the Metropolitan Branch, and will be paid by the County if it is a County Deputy slot to be filled.
- (H) The County shall be responsible for all fuel, charges associated with the County vehicles. The City shall be responsible for a monthly sum up to \$1000.00 of fuel allowance for all Metropolitan vehicles. Should all of the Metropolitan vehicles have fuel charges in excess of said \$1000.00, the County shall bear the costs of such excess.
- (I) The personnel which constitute the Metropolitan Branch shall be under the direction, supervision, authority and control of the Sheriff of Marion County, Arkansas. The City shall, upon acceptance of this agreement, provide the funds and ordinances necessary to accomplish this agreement. In a like manner, the County, upon acceptance of this agreement, shall take all steps necessary for providing the funds and ordinances necessary for the enactment and enforcement of this agreement. Each party agrees to act in the utmost good faith and to take all steps necessary of

the enforcement of the provisions and agreements contained herein.

- (J) The revenue as presently derived from Municipal Court fines shall continue to be divided between the City and the County according to the location of the offense, and the City Attorney and the County Prosecutor shall continue to cause the offenses to be prosecuted in the same manner, as was the case before this agreement. For example, should a misdemeanor citation be issued inside the corporate limits of the City, the City would retain all fines collected as a result thereof. The County in a like manner would retain all Municipal Court fines which resulted from arrests or citations within the County, but outside the City limits.
- (K) The Sheriff is authorized to use any employee as the Sheriff deems necessary which are a part of the Metropolitan Branch for the purpose of investigating alleged felony offenses of the Arkansas Criminal Code which may occur in either the County or the City. The Sheriff is authorized to use the other Metropolitan officers in any manner he deems appropriate for providing law enforcement protection for the citizens of the County and the City, recognizing, however, that the primary use of said Metropolitan Branch shall be for the protection of the residents of the City and that the primary purpose of the Yellville Summit School Resource Officer shall be the protection, guidance and nurture of the students of Yellville Summit Public School.
- (L) There shall be a Board created by the City and the County for the purpose of effectuating this Agreement and coordinating the efforts necessary for carrying out this agreement. This Board shall consist of the Sheriff of the County, the Mayor of the City, the County Judge, one (1) member of the City Council of the City of Yellville appointed by the Mayor and approved by the City Council, and one (1) member of the Quorum Court of Marion County, appointed by the County Judge and approved by the Quorum Court. The sole purpose of this Board shall be to carry out the purposes of the Agreement and to coordinate the effort of the parties that may arise from time to time.
- (M) The Interlocal Board shall meet twice a year on the third Tuesday of March and on the third Tuesday of September, the September meeting being the annual meeting. Special meetings may be called as the need arises by the Mayor, the Sheriff, the County Judge or any member of the Interlocal Board. The County Clerk and the City Clerk shall attend the annual meeting for the purpose of keeping minutes. They shall provide copies of the minutes to the City Council, and Quorum Court. At the annual meeting, the County Clerk shall give a report regarding the Sheriff's Office personnel

as to the number, salary and position of said employees. The County Clerk and the City Clerk shall attend the March regular meeting and any special meetings on a rotating basis.

- (N) The Interlocal Board shall in no way be construed to be Civil Service Commission or Grievance Committee and shall only serve for the effectuation and coordination of this Agreement.
- (O) This Agreement may be amended at any time by the majority vote of both parties. The party desiring to amend this Agreement shall draft their proposed amendment and, after passage by their governing body, submit the proposed amendment to the other party, whereupon said party's governing body shall vote upon said proposed amendment. Should the amendment be accepted by a majority of both parties, it will thereafter become a part and parcel of this Agreement. Should either party fail to approve of a proposed amendment, it will have no force or effect.
- (P) The various provisions and parts of this agreement are hereby declared to be severable and if any section or part of a section, provision herein, is declared unconstitutional, inappropriate or invalid by any court of competent jurisdiction, such holding shall not invalidate or effect the remainder of this Agreement.
- (Q) This Agreement supersedes all previous agreement and amendments thereto that relate to the Interlocal Agreement of Law Enforcement.

IN WITNESS HERETO, Marion County, Arkansas, And the City of Yellville, Arkansas, have executed this document by their duly elected officers who are authorized to represent the respective parties hereto in assuring the rights and obligations set forth herein, retroactive to January 1st, 2023 on this 9th day of January, 2023.
