#### MARION COUNTY QUORUM COURT MINUTES

August 9, 2022

The Marion County Quorum Court held their monthly meeting beginning at 6 p.m.

County Judge Massey presided over the meeting. All Justices were present. Justice Brigham gave the invocation and Justice Madden led the pledge.

The minutes and all reports were approved.

Old Business:

**New Business:** 

The motion to read by title only was made by Justice Vancuren and seconded by Justice White. The motion passed unanimously.

Ordinance 2022-45 – Boat Safety Fund – Sponsored by Justice Shipman. This motion moves \$14000.00 from the Boat Safety Emergency Fund (3019-0400) to a new fund, Boat Safety Emergency Fund - Office of Emergency Management (OEM) (3019-0500), in compliance with Arkansas Code 27-101-111. Currently this fund be being overseen by the Sheriff's office. However, the Sheriff Department does not patrol waterways within the county. This fund was established in 1989 as a rescue fund. The motion to adopt was made by Justice Scrima and seconded by Justice Nickels. During the discussion, Justice Shipman stated that the money was only being moved under a different office but would be spent in the same way. Sheriff Evans stated that he was against this change and continued to state that he had not been aware of the budget meetings when this was discussed. Justice Scrima commented that this change is just where the money is appropriated. And that he felt that there was a need for this money to be used by an established waterway patrol and rescue team. Justice Shipman continued that it was easier for the rescue team with this change, because the team is now paying for equipment out of their own pockets. He continued that Game and Fish had used some of the money for ghillie suits. He said that unless they were hiding for the people they were trying to rescue, that wasn't a good use of the money. There is a difference between enforcement and rescue. Justice Brigham called for the question. A vote was taken on the adoption of the ordinance with Justices Scrima, Nickels, Underwood, Shipman, Brigham and McCalla voting for the ordinance. Justices Vancuren and White voted against the ordinance and Justice Madden abstained. The motion passed. After the vote, Justice Vancuren stated that he thought that he was voting on "calling the question." Justice Brigham pointed out

that she did not make a motion, she had simply called for the question to end the discussion. Prosecuting Attorney, David Ethredge, (standing in for County Attorney, John Russo) was consulted and he stated that the correct procedure was followed.

Ordinance 2022-46 – Road Department – Truck Purchase – Sponsored by Justice Madden. This ordinance allow the County Judge to purchase a 2011 Ford F150 pickup truck S/N 1FTFX1EF0BFC12857 for the purpose of transporting the equipment and materials necessary for installing county road signs. The amount of \$18,000 will be appropriated from the County Road Fund (2000) to the Road Department Fund (2000-0200) vehicles line item. The motion to adopt was made by Justice Vancuren and seconded by Justice Brigham. The motion passed unanimously.

Ordinance 2022-47 – Juvenile Services – Other Professional Services, Small Equipment – Sponsored by the Budget Committee. This ordinance allows for the appropriation of \$52,435.87 from County General (Fund 1000) to The Juvenile Services budget. \$50,000 will be appropriated into the Other Professional Services line item, for the purpose of paying detention fees and \$2,435.87 into the Machinery and Equipment line item for the purpose of putting a cage in the back of their transport vehicle. The motion to adopt was made by Justice Madden and seconded by Justice Nickels. The motion passed unanimously.

Ordinance 2022-48 – Sheriff's Department – Equipping Van – Sponsored by the Budget Committee. This ordinance appropriates \$4260.00 from Fund 1005 Coronavirus Relief Fund to the Sheriff's Fund (1005-0400), \$240 goes into the Parts and Repair line item and \$4020.00 is appropriated to the Other Professional Services line item. These monies will be used to equip a van for prisoner transportation. The motion to adopt was made by Justice McCalla and seconded by Justice Madden. The motion passed unanimously.

Ordinance 2022-49 – Election Commission – Reimbursement – Sponsored by the Budget Committee. This ordinance appropriates the reimbursement from the State for Election Commission Training and Election Coordinator Training in the amount of \$1536.24. The money will be appropriated into the Election Services – Part Time (\$1400) and Meals, Miles & Lodging (\$136.24). The motion to adopt was made by Justice Nickels and seconded by Justice McCalla. The motion passed unanimously.

Ordinance 2022-50 – Appropriation – Payment for Federal Audit of Fund 3046 – Sponsored by the Budget Committee. This ordinance allows for the appropriation

of \$10000.00 from fund 3046 America Rescue to 3046-0100-3001 American Rescue Fund – County Judge Full Time Accounting & Auditing for the purpose of paying for a Federal audit of this fund. The motion to adopt was made by Justice Vancuren and seconded by Justice McCalla. The motion passed unanimously.

Ordinance 2022-51 – Appropriation – Payment for Federal Audit of Fund 1005 – Sponsored by the Budget Committee. This ordinance allows for the appropriation of \$5000.00 from fund 1005 Coronavirus Relief to 1005-0500-3001 Corona Virus Relief Fund– County Judge Full Time Accounting & Auditing for the purpose of paying for a Federal audit of this fund. The motion to adopt was made by Justice Vancuren and seconded by Justice McCalla. The motion passed unanimously.

Ordinance 2022-52 – District Court – Appropriation – Sponsored by Justices McCalla, Nickels, Brigham, Scrima and Vancuren. This ordinance appropriates \$7173.00 from County General to District Court 1000-0409-1004 Contract Labor. The motion to adopt was made by Justice Vancuren and seconded by Justice McCalla. The motion passed unanimously.

Ordinance 2022-53 – Law Enforcement – Stipend – No sponsor was listed. This ordinance appropriates \$59,207.50 from the state for the purpose of authorizing a \$5000 to each eligible full-time law enforcement officer as defined by Act 224 or the 2022 Fiscal Session of the Arkansas Legislature. The motion to approve was made by Justice Madden and seconded by Justice Underwood. The motion passed unanimously.

Resolution 2022-10 – Promise Land Sport Court – Sponsored by Justice Scrima. This resolution allows for the appropriation of \$14707.70 to complete the local match money requirement and to authorize the County Judge to submit an application of formal request to the Arkansas Rural Development Commission for the purpose of securing the grant. The resolution was adopted by an unanimous voice vote.

Judge Massey asked the court to ratify two members to the Marion County Equalization Board. Emily Smith, appointed by the Quorum Court and Tommy Dorsey, appointed by the Cities and Incorporated Towns. Their terms will expire on May 31, 2026. The voice vote was unanimous.

Judge Massey also announced that the following roads would now be considered county roads. Emily Lane Road, Robinwood Lane Road, Blue Jay Way, Jeb Road, Blackbird Circle, Yesterday Circle, Ob La Di Circle, and Elly Lane.

The meeting was adjourned.

#### Marion County Budget Committee August 24, 2022

Chairperson Joyce McCalla called the meeting to order at 5:35 pm. In attendance were Justice Scrima, Justice Brigham, Justice White, Justice McCalla and Justice Nickels.

Item #1: an ordinance setting the salary for election commissioners at \$11.50 per hour. Prosecutor Russo spoke on how the funds are distributed and added that the expenditures have not been made in accordance with the law. He suggested the quorum court needs to create an ordinance to pay the election commissioners and poll workers; it needs to be made right. Justice Scrima spoke that both the commissioners and poll workers have not been put into the numbers and comps. Clerk Moffit stated that the State of Arkansas only reimburses the county for the primary election and not the general election. Justice White questioned how the early voting affected the budget? Clerk Moffit stated that a large portion of the e election budget goes to the coding of the machines. Prosecutor Russo again stated that the election commission does need this ordinance and it's the responsibility of the quorum court to enact it. Commissioner Jimmy Lynch spoke on how things have been done and he would not charge for his presence at the meeting. Justice Brigham questioned who was responsible for the Bull Shoals election to be held 2 weeks prior to the election itself? Clerk Moffit answered it was the election commissioners themselves. Prosecutor Russo, once again added, that no election commissioner should be paid till there's an ordinance in place. Justice McCalla added that we should table this action for the next quorum meeting. Justice McCalla stated she would sponsor the ordinance.

Item #2: an appropriation ordinance in the amount of \$70,950.00, coming from line 1803 for the distribution of funds to the Marion County Fire Departments. The committee agreed to sponsor this ordinance.

Item #3: an amended appropriation ordinance from The American Rescue Fund for the amount of \$408.245.22. This ordinance will bring the E-911a much needed upgrade for its communication ability. The committee agreed to sponsor this ordinance.

Item #4 An appropriation ordinance for the coroners office for the amount of \$800.00 for body bags. The funds will be transferred from line 1005, the Corona Virus Relief Fund. The committee agreed to sponsor this action

Item #5: An appropriation ordinance requested by the assessor for the costs of corona virus tests in the amount of \$198.72. The committee agreed to sponsor this request.

Item #6 an amended appropriation from the American Rescue Fund, line 3046, for the purchase of services and equipment to support the Marion County Fire Departments communication program. The amount requested is \$170,105.30. The committee agreed to sponsor this ordinance.

Item #7 a presentation by Prosecutor Russo addressing the boating safety ordinance that was recently passed by the quorum court. Dating back to 1989, it was established that The Marion County Sheriffs Department would patrol the

waters of the county. To fix the problem, we need to talk to the sheriff elect and all involved. Sheriff Evans was asked by Justice Brigham when he first learned of this action, he responded, when he opened his packet. Prosecutor Russo added that there needs to be a public meeting to rescind this ordinance.

Item #8 Chairperson Justice McCalla questioned the committee, when should we start the 2023 budget process? Justice Scrima suggested, we start the first week of October; 10/07/22 on Tuesdays and Thursdays. Justice Scrima added he would e-mail all members of the committee a schedule.

Item #9 Mountaineer Echo Editor Robert Lyons questioned why has the posting of ordinances, been rewarded to the Baxter Bulletin? Prosecutor Russo spoke that the decision should remain with the Marion County Clerk and as the county secretary; it should be her decision

The meeting adjourned at 6:55 pm.

#### Marion County Budget Committee August 24, 2022

Chairperson Joyce McCalla called the meeting to order at 5:35 pm. In attendance were Justice Scrima, Justice Brigham, Justice White, Justice McCalla and Justice Nickels.

Item #1: an ordinance setting the salary for election commissioners at \$11.50 per hour. Prosecutor Russo spoke on how the funds are distributed and added that the expenditures have not been made in accordance with the law. He suggested the quorum court needs to create an ordinance to pay the election commissioners and poll workers; it needs to be made right. Justice Scrima spoke that both the commissioners and poll workers have not been put into the numbers and comps. Clerk Moffit stated that the State of Arkansas only reimburses the county for the primary election and not the general election. Justice White questioned how the early voting affected the budget? Clerk Moffit stated that a large portion of the e election budget goes to the coding of the machines. Prosecutor Russo again stated that the election commission does need this ordinance and it's the responsibility of the quorum court to enact it. Commissioner Jimmy Lynch spoke on how things have been done and he would not charge for his presence at the meeting. Justice Brigham questioned who was responsible for the Bull Shoals election to be held 2 weeks prior to the election itself? Clerk Moffit answered it was the election commissioners themselves. Prosecutor Russo, once again added, that no election commissioner should be paid till there's an ordinance in place. Justice McCalla added that we should table this action for the next quorum meeting. Justice McCalla stated she would sponsor the ordinance.

Item #2: an appropriation ordinance in the amount of \$70,950.00, coming from line 1803 for the distribution of funds to the Marion County Fire Departments. The committee agreed to sponsor this ordinance.

Item #3: an amended appropriation ordinance from The American Rescue Fund for the amount of \$408.245.22. This ordinance will bring the E-911a much needed upgrade for its communication ability. The committee agreed to sponsor this ordinance.

Item #4 An appropriation ordinance for the coroners office for the amount of \$800.00 for body bags. The funds will be transferred from line 1005, the Corona Virus Relief Fund. The committee agreed to sponsor this action

Item #5: An appropriation ordinance requested by the assessor for the costs of corona virus tests in the amount of \$198.72. The committee agreed to sponsor this request.

Item #6 an amended appropriation from the American Rescue Fund, line 3046, for the purchase of services and equipment to support the Marion County Fire Departments communication program. The amount requested is \$170,105.30. The committee agreed to sponsor this ordinance.

Item #7 a presentation by Prosecutor Russo addressing the boating safety ordinance that was recently passed by the quorum court. Dating back to 1989, it was established that The Marion County Sheriffs Department would patrol the

waters of the county. To fix the problem, we need to talk to the sheriff elect and all involved. Sheriff Evans was asked by Justice Brigham when he first learned of this action, he responded, when he opened his packet. Prosecutor Russo added that there needs to be a public meeting to rescind this ordinance.

Item #8 Chairperson Justice McCalla questioned the committee, when should we start the 2023 budget process? Justice Scrima suggested, we start the first week of October; 10/07/22 on Tuesdays and Thursdays. Justice Scrima added he would e-mail all members of the committee a schedule.

Item #9 Mountaineer Echo Editor Robert Lyons questioned why has the posting of ordinances, been rewarded to the Baxter Bulletin? Prosecutor Russo spoke that the decision should remain with the Marion County Clerk and as the county secretary; it should be her decision

The meeting adjourned at 6:55 pm.

It is the intent of Marion County Quorum Court that that appropriation contained herein are to be used only for county purchase of equipment and moving radio towers for county fire departments; and this ordinance is only an amendment to the 2022 county operating budget as established by ordinance 2021-124 and Ordinance 2022-

13 county operating budgets and other amendments thereto. All other appropriations and policy statements of Ordinance 2021-124 and Ordinance 2022-13 shall remain in full force and effect.

**SECTION 5.** Effective Date. This appropriation ordinance shall be effective immediately upon the passage by the quorum court and approved by the county judge in accordance with Arkansas Code Ann. 14-14-907(f).
