Tap Fee - Cleveland Utilities will provide a water connection point for connecting to the water distribution system. Cleveland Utilities provides all connections to its existing system.

Access Fee - Allows access to the water system. Fee is paid by an owner/contractor who extends new water lines including fire sprinkler lines in a development.

Wastewater Capacity Fees:

Capacity Fee per ERU July 1, 2026: 2,200

Beginning July 1, 2026, wastewater capacity fees will begin being charged for all new connections to the wastewater system. The fee is based on an Equivalent Residential Unit (ERU), which represents the average wastewater demand of a typical single-family home. For Cleveland Utilities, this is defined as up to 150 gallons per day, or 4,500 gallons (6 units) per month. Cleveland Utilities wastewater is billed in units. Please see example below:

EXAMPLE: ERU Calculation to Determine Capacity Fees for New Commercial/Industrial Business

"Acme, Inc." proposes a new manufacturing facility in CUA service area
Estimates its new facility will discharge wastewater at an average flow of 6,000 gallons per day and submits its application to CUA accordingly.

CUA reviews the application from Acme, Inc. pursuant to the proposed model and decides to approve the request of 6,000 gallons per day.

Therefore, the capacity fees assessed to Acme, Inc. will be 40 times the approved ERU rate.

ERU Capacity Calculation:

$$6,000 \text{ GPD} / (150 \text{ GPD for 1 ERU}) = 40 \text{ ERUs}$$
