Resolution No. 26-13

A RESOLUTION DESIGNATING JASON E. THIS, VILLAGE SOLICITOR OF THE VILLAGE OF BOTKINS AS THE PUBLIC RECORDS AND OHIO SUNSHINE LAW TRAINING DESIGNEE FOR THE MAYOR AND THE VILLAGE COUNCIL AND VILLAGE ADMINISTRATOR AND VILLAGE FISCAL OFFICER OF THE LEGISLATIVE AUTHORITY OF THE VILLAGE OF BOTKINS.

WHEREAS, Sections 149.43(E)(1) and 109.43(B) of the Ohio Revised Code require all elected public officials or their designees to attend a public records and Ohio Sunshine Law training seminar approved by the Attorney General's Office; and

WHEREAS, The Village Council of the Village of Botkins desires to designate the Village Solicitor as the designee for the mayor and all village council members, its administrator and its fiscal officer as the public records and Ohio Sunshine Law training seminar attendee designee for elected officials until the next election period pursuant to Ohio Revised Code Section 149.43(E)(1).

WHEREAS, the Village Solicitor will attend a virtual or live certified public records training to meet the requirements for 2026 and 2027;

NOW, THEREFORE, be it resolved by the Council of the Village of Botkins:

SECTION 1:

The Village Council of the Village of Botkins desires to designate the Village Solicitor as the designee for the mayor and all village council members, the Village administrator and Village Fiscal Officer as the public records and Ohio Sunshine Law training seminar attendee designee until the next election of officers pursuant to Ohio Revised Code Section 149.43(E)(1).

SECTION 2:

The Village Solicitor will take all mandated trainings and will report any concerns or changes to the Mayor and Legislative Authority.

SECTION 3:

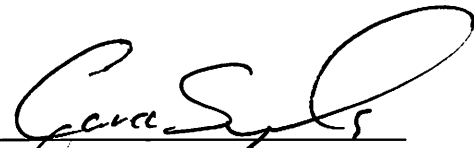

compliance with all legal requirements including Sections 121.22 of the Ohio Revised Code.

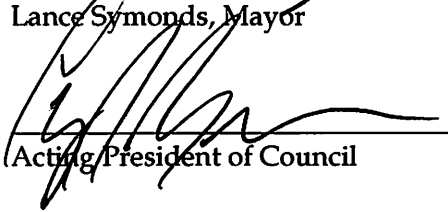
SECTION 4:

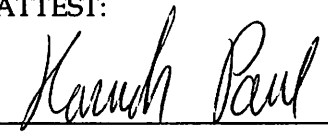

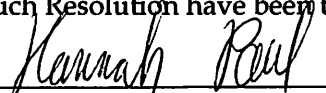
