- 1. Income exceeded year to date (YTD) pledge estimates due to our very generous donors.
- 2. Payrolll Expenses were higher in August due to large payments of accrued vacation time paid to our DFO and Administrator. The Personnel Policy has been changed to minimize the amount of accrued vacation that an employee can accumulate. The budgeted amount for payroll was established basedc on the assumption that staffing would be cut in July but that did not occur until August. Payroll expenses are expected to fluctuate until the full month of December.
- 3. Operational expenses are slightly higher in the month of July due larger projects such as replacing the railing in the balcony.
- 4. Overall expenses exceeded the budget due to payroll expenses and operating expenses.
