- b. Financial Report
  - o Audit update:
    - The audit has begun.
    - Ted Norris appointed to the Audit Committee by the Executive Committee during their April meeting.
    - One more candidate is being recruited to round out the Audit Committee.
  - Loose offerings have increased lately, coinciding with the return to passing the collection plate during worship services.
  - o Current cash balance: \$621,400 (total T-Bill investment: \$686,915)
