- b. Motion made by Andrew, 2nd by Kim. Motion passed unopposed with 2 abstentions.

4. Reports & Presentations

- a. Executive Committee Jenny Mohler
 - Pastors Frank and Amy, with Jenny and Jo, met with members of the old First English church to discuss possible uses for the proceeds from the sale of that property.
 - o A proposal to spend some of the money will be brought forward at a future Council meeting.
- b. Financial Report Kurt Galvez
 - o Projecting to run a surplus of around \$100K for the year.
 - o Audit committee looking for new leaders to perform audit in 2023.
 - o Current cash balance: \$696,355

5. Action Items

a. 2023 Budget - Kurt Galvez

Unrestricted

- Motion brought by Kurt and the Finance Committee: Approve the draft 2023 Budget (as presented) and send to the Annual Meeting of the Congregation for adoption.
 - Amendment brought by Robin and seconded by Shelley to reallocate half the money budgeted for Synod benevolence to the Pastor's Discretionary Fund. Motion was withdrawn.
 - Motion passed with 1 opposed and 2 abstention. Budget will be presented at the Annual Congregation Meeting.
- Key points discussed:
 - Removed Youth and Family position that had been planned, replacing in budget with temporary help to cover Pastor Jon's sabbatical.
 - Grant income from IRS and Lily Foundation grant added in to reflect current expectations.
 - No money planned for Property Fund.
 - Questions raised about Restricted Funds and how they're allocated that was tabled until a future meeting.

6. Discussion Items

- a. Vision work
 - o Vision is still in discussion and hopes to be presented during January Council meeting.
- b. Racial Justice Ministry
 - Racial Justice Internal Change committee's commissioning mandate was offered for discussion, but Pastor Frank and the committee decided to withdraw it for further discussion and revision before coming back to Council.
