b. 1st English Speaker Series proposal

- o Motion brought by Jo, Jenny and the Pastors: *Release \$10,000 for speaker and travel fees to have Marilyn Nelson come to Sacramento for a speaker event sponsored by St. John's and in honor of the legacy of First English Church.*
- Friendly amendment made by Joel to add 2 contingencies to the motion: 1) that Hiram Johnson High
 School accepts having Marilyn as commencement speaker and 2) there is an event planned to be held at St.
 John's with Marilyn. Amendment was 2nd by Robin Keller and accepted by the Chair.
- o Motion passed with 1 opposed and 1 abstention.

c. Reinvestment of T-Bills

- o Motion brought by Kurt and Finance Committee: Re-invest \$250,000 in Treasury Bills.
- o Motion passed unopposed with 1 abstention.
