- 1. Call meeting to order & Establish Quorum: 6:00pm (Tim).
  - **a.** To establish quorum, we need 20% of homeowners represented, which is 17. We have 17 properties represented in person and 18 represented by proxy, to give us a total of 35. Quorum has been established.
- **2. Approval of 2023 Annual Meeting Minutes:** Ryan Sodikoff motions to approve the minutes as written, Beth Beahm seconds, motion carries.

#### 3. Reports:

- a. President (Tim):
  - The ARC guidelines have been established.
  - Will take care of fixing the lights at the entrance sign off Wexford and Pleasant Valley Rd.
- b. Treasurer (Charlie): None.
- c. POA Manager:
  - ARC Guidelines Legal review was done on the ARC guidelines document, and it was finalized and approved by the Board; it has been posted to the website and was sent to all owners.
  - Retention Pond Beautification The scheduled plantings for the retention ponds are scheduled for early December.
    - Mike Loso: 55 trees will be planted around the perimeter of the 3 retention ponds, and the work is being done by Shreckhise. The scheduled start date is December 2<sup>nd</sup> and is dependent upon weather. The plans were approved by Rockingham County.

- Investments \$40,000.00 has been invested in a 12-month CD at an interest rate of 4.3%, maturing September 2025.
  - \$50,000.00 had previously been invested, but \$10,000.00
    was pulled out and deposited into the operating account to
    help with funding of the retention pond beautification
    project per direction from the Board.
- VDOT Transition VDOT is scheduled to take over the roads in spring 2025, so all maintenance and snow removal will be done by them and will not fall upon the association.
- **4. Financial Review (YTD, October 31**<sup>st</sup>): Through the end of October, the association has \$34,658.79 in total operating income and \$29,195.48 in total operating expense, for a net income of \$5,463.31, which is over \$1,100 ahead of budget for the year.

### 7. Open Forum:

- **a.** Beth Beahm announces that there will be a ladies Christmas coffee being held on Thursday, December 12<sup>th</sup>, from 9-11am at 2805 Huntington Springs Drive. More information will be sent to Rocktown to send to all owners and will also be posted on the association's Facebook page.
- **b.** An owner asks if anything can be done regarding construction vehicles going through the community and if access can be limited to only the second entrance.
  - Gary Crummett states that per VDOT, we cannot restrict anyone from accessing the street.
  - Rocktown will do its best to contact the construction companies about speeding and using the second entrance to enter the community.
- **c.** Another owner mentions that the main entrance sign is blocked by a plant and asks if this can be removed entirely.
  - The Board will discuss this at next week's Board meeting.
- **d.** Lindsey Sodikoff mentions how great the Halloween event was and that it was good to see everyone and the costumes.
