### Mixed Private and Funded Example:

#### 2 Days per week, 15 hours funded

Funded Fees (term time) = £40.50 x 38 weeks ÷ 12 months = £128.25

Private Fees (non term time) = £81.00 x 2 days x 14 weeks ÷ 12 months = £189.00

Total = £128.25 + £189.00 = £317.25

### Mixed Private and Funded Example:

#### 2 Days per week, 15 hours funded

Funded Fees (term time) = £59.26 x 38 weeks ÷ 12 months  
= £187.66

Private Fees (non term time) = £81.00 x 2 days x 14 weeks  
÷ 12 months = £189.00

Total = £187.66 + £189.00 = £376.66

Private Fees (non term time) = £75.00 x 2 days x 14 weeks ÷ 12 months = £175.00

Total = £196.65 + £175.00 = £371.65

All bookings are subject to our terms and conditions of service, which we reserve the right to review at any time. For a copy of the latest terms and conditions of service please contact the Nursery Manager.



All private fees form part of an inclusive service: all meals, snacks, (including accreditations and preparation by a qualified Chef), consumables (nappies, wipes, sun cream), extracurricular activities, outings, and events.

## Monthly fee calculation

Number of funded sessions per week x 38 weeks plus number of private sessions per week x 14 weeks, divided by 12 months = your monthly bill.

However if you do not use funded sessions then, number of private sessions per week x 52 weeks divided by 12 months = your monthly bill

Our fees are calculated on a pro-rata basis, therefore your monthly invoice amount is always the same regardless of how many weeks are in the month.

When a child moves from one age group to the next, the fee change will take effect in the month following their birthday.

## Funded Nursery Entitlement

Your child may be entitled to funded nursery education during term time.

It does not cover the cost of meals, consumables, outings, extracurricular activities, and events. To cover costs not included during the funded hours, providers can charge a voluntary contribution for these costs.

Funded hours are allocated for universal 570 hours per year for 38 weeks of the year. Children of families satisfying the eligibility criteria can access an additional 570 hours per year, over 38 weeks.

## Funded Hours Provision

### Availability of Funded Hours

Funded childcare hours may be claimed during the nursery's standard operating hours, which may vary by location. At Toad Hall Nursery group, funded hours are offered in 5, 7.5 or 10 hour blocks commencing from the time the nursery opens. Parents/carers are advised to check with their local nursery for specific operating hours and availability.

### Use of Funded Hours and Additional Charges

In line with current government guidance, parents/carers may choose to opt out of paying a contribution for certain essentials and extras provided during the funded hours. However, where this option is exercised, the nursery will continue to provide the standard services and consumables at its own cost. All private or mixed funded models are inclusive of the voluntary contribution. Please note that the government funding does not cover the full cost of delivering these services, and therefore this arrangement represents a financial commitment by the nursery. A deposit and Reg fee will not be required for Funded only models.

### Sustainability of the Funding Model

The current flexible model for offering funded hours and services is designed to be sustainable for both families and the nursery. Toad Hall reserves the right to review and amend this model at any time in response to changes in government guidance, funding structures, or operational viability. Families will be notified of any such changes in advance, in accordance with the terms of this agreement.

## Important information:

For termination of contract, or for changes to your booking pattern, we require in writing, not less than one full calendar month's notice ending on the last day of that billable month.

Starting/changes to sessions midway through the month, not following the one full calendar months notice (as above) will result in your invoice being charged at the sessional rates.

Your final invoice will not be annualised and will be charged at your daily sessional rate, if you fail to give one full calendar month's notice.
