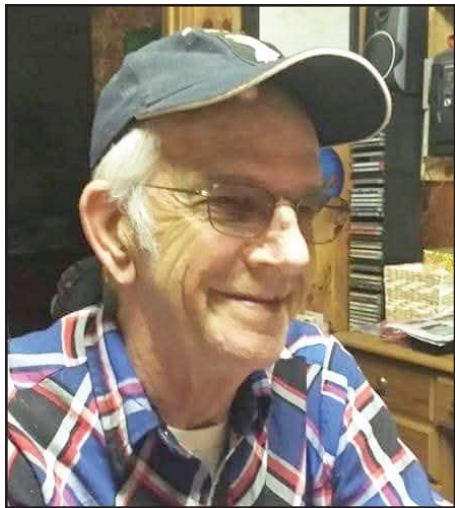
Foster O. Decker, 85, of Woodhull NY, passed away December 27, 2025, at the Robert Packer Hospital.

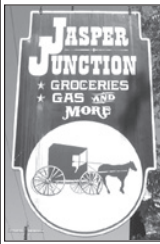
