**Homework Hub/Academic Flex**

Addison High School has two new initiatives that have been started this year for supporting students. One is referred to as Homework Hub and the other is Academic Flex. During Homework Hub, students are assigned to Mrs. (Jessica) Clark or Mrs. Sindlinger and are provided with a quiet space to complete their homework. 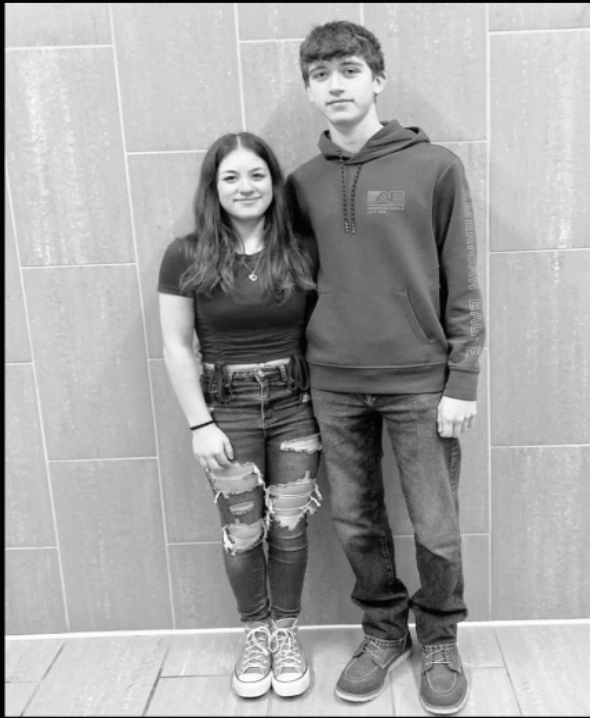
