### **Family Heirloom Finds New Home**

A historic family heirloom has found a new home in Addison after Hal Sisson completed a full restoration of an 1865 sleigh cutter that had been in his family for more than 150 years.

The sleigh, originally built in Wellsville and purchased by Sisson's ancestor shortly after the Civil War, was passed down through generations before reaching him. For two years, Sisson generously loaned it to Flint Funeral Home, where it was used as a Christmas display.

When he decided it was time to part with the sleigh, Flint Funeral Home purchased it and asked Sisson to restore it. Despite its age, the structure remained sound, though the body required extensive repair, including a new ash floor and major refinishing work. After the restoration was completed, the upholstery was professionally redone by Capabilities Inc. of Elmira.

Now fully renewed, the sleigh will be cared for by Flint Funeral Home and enjoyed by the community during future holiday seasons.



### TOWN OF LINDLEY

Simplifying the STAR program Beginning in 2026, seniors no longer need to apply to their assessor to qualify for Enhanced STAR. In addition, only one resident owner of the property—regardless of the relationship of the owners—must be at least 65 years of age as of December 31 of the benefit year.

This simple change may make it easier to receive Enhanced STAR. Homeowners will be notified if they qualify for an Enhanced STAR exemption. A letter will be sent to Basic STAR exemption recipients who may be eligible for the Enhanced STAR exemption.

A new webpage about the STAR changes will be launched shortly, and we'll provide a printable handout to explain the changes. Exemption recipients will not need to apply online. However, we encourage recipients to confirm their information is up to date in the Homeowner Benefit Portal.
