The Project includes the following Work:

Project involves Roadside Channel restoration project for Grinnold Road. The project involves the modifications of the roadside channel on the north side of Grinnold Road. The existing stone will be removed, and the channel will be reshaped per plans to accommodate anticipated flow. The channel will be armored with medium size stone. Check dams will be installed as part of this work; dams will be also constructed of medium stone. Three (3) cross pipes are proposed with various sizes based on hydrological calculations as shown on the plans. Driveway culverts along the channel will be replaced. 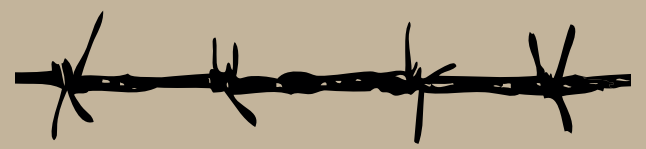

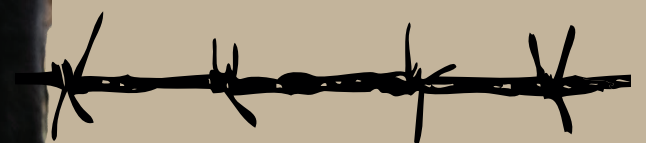
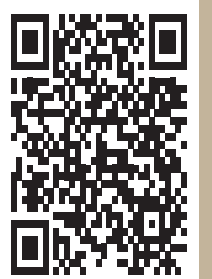
