6. Discuss and consider approval of transfers among District accounts;



9. Receive status report from Commissioners on District-related work since the previous month's meeting;
10. Receive General Counsel report, including, but not limited to, tax matters, pending contract issues, open records requests, and other legal issues, if any, and take action as needed;

11. Discuss and consider action on stations, including renovations to existing stations and the new Meridian station, and issues related to the operation or maintenance of the stations;
12. Discuss and consider action on real estate purchase and development and receive report from Steering Committee regarding same;

14. Discuss and consider submitting required annual report to the Division of Emergency Management;
