7. Discuss and consider approval of any revenue transfers among District accounts;

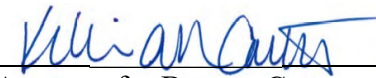

11. Receive General Counsel report, including, but not limited to, tax matters, pending contract issues, open records requests, and other legal issues, if any, and take action as needed;
