1. Call meeting to order;
2. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.
3. Public Comment on Agenda Items: Members of the public may comment on any agenda item listed below. Members of the public may speak for up to two minutes per agenda item on which they comment.

6. Discuss and consider any revenue transfers among District accounts;

7. Receive monthly report from North Bosque EMS regarding emergency operations, response times, call volume, training, management activities, personnel and membership and take any related action;
8. Receive monthly report from Bosque Valley First Responders Organization regarding emergency operations, response times, call volume, training, management activities, personnel and membership and take any related action;
9. Receive status report from Commissioners on District-related work since the previous month's meeting;
10. Receive General Counsel report, including, but not limited to, tax matters, pending contract issues, open records requests, and other legal issues, if any, and take action as needed;

11. Conduct annual review of investment policy and investment strategies and adopt resolution;
12. Review and approve quarterly investment report for 1st quarter;
13. Discuss and consider plans for a future EMS facility, including a lease for same; and
