Notice is hereby given that a meeting of the Board of Commissioners of Bosque County Emergency Services District No. 1 will be held on **Thursday, August 5, 2021, at 3:00 p.m.**, at the District office, 305 E. Morgan, Meridian, Texas, for the following purposes:

**Due to the state of emergency and/or local disaster caused by the COVID-19 pandemic, the Board of Commissioners of Bosque County Emergency Services District No. 1 may hold its meeting via telephone conference call because of the difficulty and risks of convening a quorum in one location. If initiated, the call will be broadcast at the meeting location and recorded as required by the Texas Open Meetings Act.**

1. Call meeting to order;
2. Public Comment: In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.
3. Public Comment on Agenda Items: Members of the public may comment on any agenda item listed below. Members of the public may speak for up to two minutes per agenda item on which they comment.

4. Consider taking action regarding 2021-22 budget;
5. Discuss and consider taking action regarding 2021 tax rate, including:
  - (a) establishing proposed tax rate;
  - (b) taking record vote and scheduling public hearing;
  - (c) authorizing publication of "Notice of Public Hearing on Tax Increase" in the *Clifton Record and Meridian Tribune*; and
  - (d) acknowledging and approving posting of Notice About 2021 Tax Rates and "Notice of Public Hearing on Tax Increase" to home page of District website; and
6. Discuss time, place, date and agenda items for next meeting.
