1. Call meeting to order;
2. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.

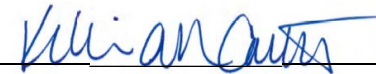
9. Receive monthly report from North Bosque EMS regarding emergency operations, response times, call volume, training, management activities, personnel and membership and take any related action;

11. Receive status report from Commissioners on District-related work since the previous month's meeting;

12. Receive General Counsel report, including, but not limited to, tax matters, pending contract issues, open records requests, and other legal issues, if any, and take action as needed;

13. Discuss and consider stations, including renovations to existing stations and the new Clifton station, and issues related to the operation or maintenance of the stations;
14. Discuss and consider approval of Bosque Central Appraisal District real estate acquisition;
15. Take a record vote on the District's 2024 tax rate, adopt an Order Levying Taxes, authorize filing the Order with the County Tax Assessor/Collector;
16. Acknowledge and approve posting of statement regarding adopted tax rate to home page of District website;
