Notice is hereby given that a meeting of the Board of Commissioners of Bosque County Emergency Services District No. 1 will be held on **Thursday, August 26, 2021, at 3:00 p.m.**, at the District office, 305 E. Morgan, Meridian, Texas, for the following purposes:

**Due to the state of emergency and/or local disaster caused by the COVID-19 pandemic, the Board of Commissioners of Bosque County Emergency Services District No. 1 may hold its meeting via telephone conference call because of the difficulty and risks of convening a quorum in one location. If initiated, the call will be broadcast at the meeting location and recorded as required by the Texas Open Meetings Act.**

1. Call meeting to order;
2. Public Comment: In accordance with the Texas Open Meetings Act, any response to a public comment that is made on an item that is not on the published final agenda will be limited to a statement of factual information or a statement of existing policy given in response to the public comment. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.
3. Public Comment on Agenda Items: Members of the public may comment on any agenda item listed below. Members of the public may speak for up to two minutes per agenda item on which they comment.

**ADMINISTRATIVE ITEMS**

4. Discuss and consider minutes of the July 30, 2021, regular meeting and August 5, 2021, special meeting;
5. Discuss and consider Treasurer's report and the payment of rent, invoices, advertising expenses, and reimbursements owed to Commissioners for out-of-pocket expenses;
6. Review and approve the investment report for the second quarter;
7. Discuss and consider any revenue transfers among District accounts;
8. Discuss and consider amendments to FY21 budget, if needed;

**REPORTS**

9. Receive monthly report from North Bosque EMS regarding emergency operations, response times, call volume, training, management activities, personnel and membership and take any related action;
10. Receive monthly report from Bosque Valley First Responders Organization regarding emergency operations, response times, call volume, training, management activities, personnel and membership and take any related action;

11. Receive status report from Commissioners on District-related work since the previous month's meeting;
12. Receive General Counsel report, including, but not limited to, tax matters, pending contract issues, open records requests, and other legal issues, if any, and take action as needed;

#### **DISCUSSION/ACTION ITEMS**

13. Consider taking action regarding budget for fiscal year October 1, 2021 to September 30, 2022 and adopt a Resolution for same;
14. Conduct a public hearing on the proposal to increase property taxes;
15. Take a record vote on the District's 2021 tax rate, adopt an Order Levying Taxes, authorize filing the Order with the Bosque County Tax Assessor/Collector; and
16. Authorize posting of statement regarding adopted tax rate to home page of District website;
17. Discuss and consider availability of funds from federal programs and stimulus plans; and
18. Discuss time, place, date and agenda items for next meeting.
