1. Call meeting to order;
2. Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.
3. Public Comment on Agenda Items: Members of the public may comment on any agenda item listed below. Members of the public may speak for up to two minutes per agenda item on which they comment.

9. Receive status report from Commissioners on District-related work since the previous month's meeting;
10. Receive General Counsel report, including, but not limited to, tax matters, pending contract issues, open records requests, and other legal issues, if any, and take action as needed;

12. Discuss and take any related action regarding a Board officer election;
