Any deliberation or decision by the Board must be limited to a proposal to place the subject on a future agenda.
3. Public Comment on Amended Agenda Items: Members of the public may comment on any agenda item listed below. Members of the public may speak for up to two minutes per agenda item on which they comment.

9. Receive monthly report from Bosque Valley First Responders Organization regarding emergency operations, response times, call volume, training, management activities, personnel and membership and take any related action;
10. Receive presentation from the Bosque Valley First Responders Organization on budget and funding issues and take any related action;
11. Receive status report from Commissioners on District-related work since the previous month's meeting;


12. Receive General Counsel report, including, but not limited to, tax matters, pending contract issues, open records requests, and other legal issues, if any, and take action as needed;
