On funded pre-arrangements, we accept checks only, made payable to the insurance company underwriting the policy.

Prior to drafting any contract for goods and services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

## Services, Facilities & Equipment

**1. Basic Service Fee** \$430  
This is a basic fee that we charge every family for our professional service in assisting them with their preferences. It includes a proportionate share of our overhead required to serve the public. Our charge includes but is not limited to consultation with the family, administrative and clerical services, preparation of the death certificate for certification of the attending physician or coroner, consultation with cemetery or common carrier, our availability 24 hours a day to bring your loved one into the care of our affiliate O'Connor Mortuary – Laguna Hills and to answer questions you may have. This fee also includes placement of obituary notices on-line at [www.pacificcreationservices.com](http://www.pacificcreationservices.com). This fee for our basic services and overhead will be added to the total cost of the arrangements you select. (This fee for our basic services and overhead is already included in our charges for direct cremation).

**2. Transfer of Your Loved One into the Care of Pacific Cremation Services** \$385

**3. Refrigeration and Care for Your Loved One while at Our Facility** \$430

After 7 days, \$50 per day

**4. Cremation and Processing of cremated remains (Other than Direct Cremation)** \$430

**5. Professional Embalming** \$675  
Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing or if you wish your loved one to be dressed. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.

**6. Other Professional Care of Your Loved One (all professional care is performed at O'Connor Mortuary)**

- Dressing, Cosmetology and Casketing (**\$375**)
- Custodial Care (**After 7 days, \$50 per day**)

## Cremation Options

**Direct Cremation** \$1,625 - \$1,675

**Includes:** adjusted administrative and professional services of the funeral director and staff, transfer of your loved one to O'Connor Mortuary – Laguna Hills, refrigeration, cremation and processing of the cremated remains. This charge does not include memorial products, use of our facilities, equipment and staff for identification viewing or cash advance items.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard, or composite materials (with or without an outside covering). The containers we provide are cardboard, fiberboard, or willow.

**Direct Cremation with container provided by family** \$1,625

**Direct Cremation with cardboard container** \$1,675

**Direct Cremation with container or casket (Cost of Casket or Container is additional)** \$1,625
