Dear Folks,

As we are busily preparing for our 76th fair in 2025, we have set our dates this year for August 21st 22nd, and 23rd. The gates will be open at 7 AM on Friday, Saturday and Sunday. The Rental Agreement is outlined below, and a separate rental agreement is attached. If you or your group/organization plans to rent a space/booth, you must return the application to the fair with a 50% deposit by June 1, 2026. If you also require camping information, please refer to our website and download the Regular Camping Rental Agreement found in the Livestock & 4-H Section.

Rental Agreement

The following rules and regulations will apply to all persons or organizations renting space on the fairgrounds:

- 1) No pets will be allowed on the fairgrounds between 7 AM Friday and 7 PM Sunday.
- 2) Camping is prohibited unless facilities are an integral part of the booth or space setup.
- 3) No alcoholic beverages are allowed on the fairgrounds.
- 4) No obscene or political literature/merchandise may be displayed, sold, or distributed on the grounds.
- 5) No merchandise advertising 'Cornish, NH' or "Cornish Fair" is allowed to be sold.
- 6) No advertising, selling, or use of any drugs or drug related materials are allowed on the fairgrounds.
- 7) No automobiles will be allowed to park on the grounds except in defined parking areas.
- 8) Food booths are to abide by the State of New Hampshire rules for Temporary Food Service Establishments.
- 9) Each vendor is expected to keep the grounds clean around their booths.
- 10) Waste oil must be properly disposed of in the proper EcoOil Recycling Container (located by the Speakers Booth).
- 11) **Each vendor who rents space is given two 3-day passes. The vendor is expected to make arrangements with their workers/helpers for entrance fee. The ticket booths require payment or a pass at time of entry.**
Note: We do sell discounted admission tickets through Thursday August 20th – see the Grounds Director.

The following policies are in effect:

- 1) Space is assigned at the discretion of the Grounds Director.
- 2) The Grounds Director will admit a limited number of similar booths, application submission does not guarantee rental.
- 3) Electrical use is limited to lights, refrigerators, coffee urns and small equipment. Use of electric fry pans and/or grills are prohibited. The renter is responsible to ensure their booth is firmly secured.
- 4) Renter of booth/space must supply liability insurance coverage in the amount of \$1,000,000. We must receive this certificate of insurance by July 1, 2026. The Cornish Fair Association must be listed as additional insured for August 21, 22 and 23, 2026.
- 5) No wheeled vehicles or automobiles will be allowed on the grounds after 7 AM Friday.
- 6) The renter must make his/her own arrangement for banking.
- 7) Our fair will begin promptly at 7 AM Friday, and Midway opens daily at 10am. Rental spaces must remain open until 10pm on Friday and Saturday, and until 7 PM on Sunday. Early dismissal must be approved by a Vendor Director. If you leave early, you will not be invited back next year.
- 8) We cannot guarantee you the same spot you had last year.
- 9) All hoses and electrical wires crossing walk ways must be covered with mats or buried in the ground.
- 10) There will be no refunds after August 1, 2026.
- 11) **The Fair Directors will make the final decision regarding what goods will be displayed, sold, or distributed on the fairgrounds.**
