CAMPING RENTAL RULES

SPEED LIMIT INSIDE THE CAMPING AREAS IS 5 MPH

Campers may be brought in beginning the Saturday before the Fair begins.

Rental period is from Thursday before the Fair through Monday morning after the fair.

General Rules:

-
- Camper tags must be displayed at all times. No tag = no camping. Camping vehicle passes must be displayed at all times and only indicate where you are able to park.
 - The pass is NOT an admission pass. You must fit your entire camper and vehicle within the assigned spot. No vehicles will be parked within the Fire Lane at any time.
 - If your vehicle cannot fit in your assigned spot with your camper, you must park in public parking. You may not park in front of another camper.
 - This policy will be strictly enforced. All campers will occupy & place equipment on the assigned campsite **ONLY!**
 - **Campsite holder is responsible for the conduct of everyone** staying at this site & is liable for any violations of the rules & regulations.
 - All campers under 18 years old **MUST** be accompanied & supervised by the campsite holder.
 - Any tent or other camping equipment left unoccupied for more than 48 hours may be taken down & forfeited.
 - There is no use of generators of any kind. Violators of this policy will be removed. Appropriately language and acceptable clothing must be maintained at all times.

Pets:

- No pets allowed.
- Service dogs will be allowed only with the required documentation.

Campfires:

- No campfires are permitted on the grounds at any time.

General Behavior:

- Quiet hours must be observed from 10 PM to 7AM
- No person under the age of 21 years of age shall possess alcoholic beverages (must be able to provide adequate proof of age upon request)
- All garbage shall be deposited in designated barrels.
- No obstructing vehicle or pedestrian traffic at any time
- No fighting or violent, tumultuous or threatening behavior..
- Firearms are not permitted on the property without consent.
- **NO FIREWORKS**
- Campers/visitors will not deface, remove, destroy property or cut any branches/foilage in the camping area.
- Campers and their guests will be held financially responsible for any damage to camping area property and may be subject to legal action.
- Music/Noise is to be kept low so as to not disturb other campers.
- Spotlights or other lighting that creates a disturbance to other sites are not permitted. Cornish Fair Association, its officers and directors will not be responsible for loss or damage due to theft or for any accident or injury to persons or their property.

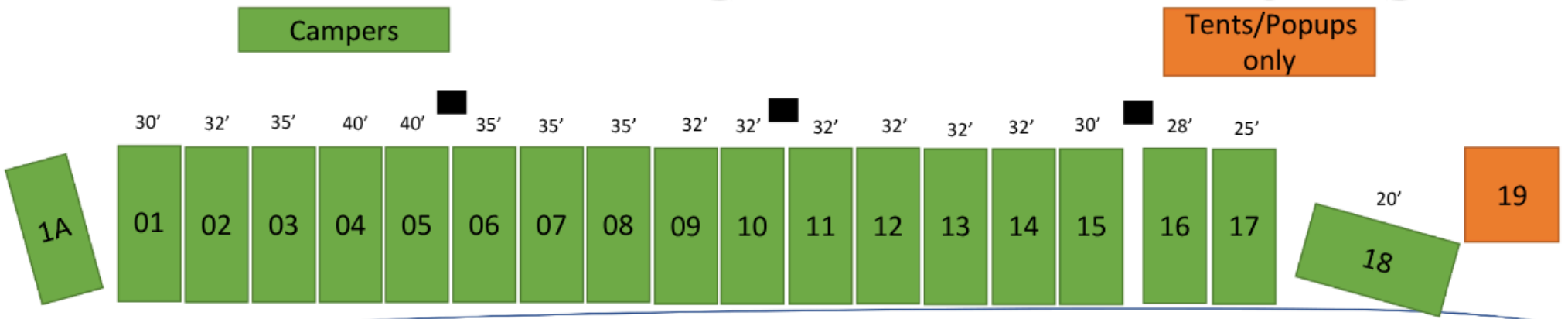

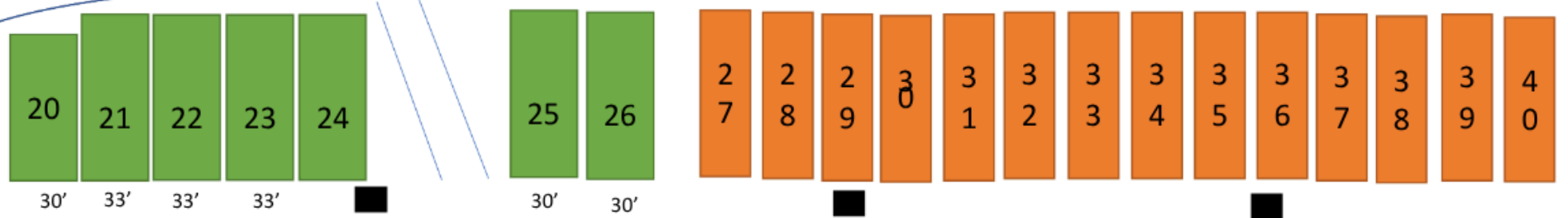
