

Christmas Cash Giveaway

Terms & Conditions

1. Promotional Period

- 1.1 Armidale City Bowling Club (ACBC) "Christmas Cash Giveaway" promotion ("Promotion") commences at 9am on the 21st November 2025 with the final draw on Sunday 21st December 2025

2. Entry Requirements

- 2.1 Entry is open to all financial members of ACBC and is via:

Entry Kiosks - Swiping a membership card at the clubs entry kiosks during the promotional period. Members will be entitled to one (1) entry per draw day, valid only for the duration of the draw date and will be awarded a daily number of entries based on Advantage Plus Tier, Diamond Plus receive 5 daily entries, Diamond receive 4 daily entries, Platinum receive 3 daily entries, Gold receive 2 daily entries and Advantage receive 1 daily entry per day.

- 2.2 Members gaining entry into the draw will be entered into the Virtual barrel **Christmas Cash Giveaway**

3. Draws and Prizes

- 3.1 There will be Ten (10) draws conducted from the **Christmas Cash virtual barrel** on the following dates: Friday 21st November 2025, Sunday 23rd November 2025, Friday 28th November 2025, Sunday 30th November 2025, Friday 5th December 2025, Sunday 7th December 2025, Friday 12th December 2025, Sunday 14th December 2025, Friday 19th December 2025 and Sunday 21st December 2025.
- 3.2 For the draw there will be 1 (one) winner drawn out of all entries in the barrel. The winner will be given 2 (Two) minutes to make themselves known to drawer. The winner's name and membership number will be announced over the Clubs internal PA system.
- 3.3 If the winner is not present after 2 minutes the prize will be again drawn, and this will continue until a winner is present.
- 3.4 There will be TWO (2) major prizes, provided by ACBC of \$3000 cash and \$2000 cash. There will be EIGHT (8) minor prizes of \$500 Cash provided by ACBC
- 3.5 The winner drawn at each date may choose to take the prize in cash.
- 3.6 The prize providers are Armidale City Bowling Club
- 3.7 Only the amounts listed on the draw dates will be given away

4. Identification

- 4.1 Winners must be present to claim their prize and they must produce a financial membership card to claim their prize.

5. General

General
