

'Holiday & Cash Splash'

Terms & Conditions

1. Promotional Period

- 1.1 Armidale City Bowling Club (ACBC) "Holiday & Cash Splash Virtual Draw" promotion ("Promotion") commences at 9am on Wednesday 1st April 2026 and ends Friday 26th June 2026 with the draw on Friday 26th June 2026 at 7:30pm.

2. Entry Requirements

- 2.1 Entry is open to all financial members of ACBC and is via:
Foyer Entrance Kiosk - Swiping a membership card at the clubs entrance terminal during the promotional period. Members will be entitled to one (1) entry per day.
- 2.2 Members gaining entry will automatically go into the virtual barrel before the draw date to be eligible. The virtual barrel will remain full for the entire promotional period.

3. Draws and Prizes

- 3.1 There will be One (1) draw conducted from the **Holiday & Cash Splash Virtual Draw** on the following date:
Friday 26th June 2026
- 3.2 For the draw there will be 1 (one) winner drawn out of all entries in the virtual barrel. The winner will be given 2 (Two) minutes to make themselves known to drawer. The winner's name and membership number will be announced over the Clubs internal PA system.
- 3.3 If the winner is not present after 2 minutes the prize will be again drawn, and this will continue until a winner is present.
- 3.4 There will be one (1) major prize valued at \$5000, provided by ACBC which provides the winner with a \$3000 Travel Voucher to be used with New England Travel and \$2000 Cash
- 3.5 The prize is valid from date of issue and the voucher can be used at the business in person.
- 3.6 Only one prize will be given away
- 3.7 The prize is non-refundable and cannot be redeemed for cash

4. Identification

- 4.1 Winners must be present to claim their prize and they must produce a financial membership card to claim their prize.

5. General

General
