

'Shop 'Til You Drop'

Terms & Conditions

1. Promotional Period

- 1.1 Armidale City Bowling Club (ACBC) "Shop 'Til You Drop Virtual Draw" promotion ("Promotion") commences at 9am on Thursday 1st January 2026 and ends Friday 27th March 2026 with the draw on Friday 27th March 2026 at 7:30pm.

2. Entry Requirements

- 2.1 Entry is open to all financial members of ACBC and is via:
Foyer Entrance Kiosk - Swiping a membership card at the clubs entrance terminal during the promotional period. Members will be entitled to one (1) entry per day.
- 2.2 Members gaining entry will automatically go into the virtual barrel before the draw date to be eligible. The virtual barrel will remain full for the entire promotional period.

3. Draws and Prizes

- 3.1 There will be One (1) draw conducted from the **Shop 'Til You Drop Virtual Draw** on the following date: Friday 27th March 2026
- 3.2 For the draw there will be 1 (one) winner drawn out of all entries in the virtual barrel. The winner will be given 2 (Two) minutes to make themselves known to drawer. The winner's name and membership number will be announced over the Clubs internal PA system.
- 3.3 If the winner is not present after 2 minutes the prize will be again drawn, and this will continue until a winner is present.
- 3.4 There will be one (1) major prize valued at \$4000, provided by ACBC which provides the winner a \$1000 Intersport Voucher, a \$1000 Harvey Norman Voucher, a \$1000 Bing Lee Voucher and a \$1000 Bunnings Voucher.
- 3.5 The prize is valid from date of issue and each voucher can be used at the select business, online or in person.
- 3.6 Only one prize will be given away
- 3.7 The prize is non-refundable and cannot be redeemed for cash

4. Identification

- 4.1 Winners must be present to claim their prize and they must produce a financial membership card to claim their prize.

5. General

General
