

# 'Sports Travel Experience'

## Terms & Conditions

## 1. Promotional Period

1.1 Armidale City Bowling Club (ACBC) "**Sports Travel experience Virtual Draw**" promotion ("Promotion") commences at 9am on Saturday 26<sup>th</sup> July and ends Friday 7<sup>th</sup> November with the draw on Friday 7<sup>th</sup> November 2025 at 7:30pm.

## 2. Entry Requirements

- 2.1 Entry is open to all financial members of ACBC and is via:
  Foyer Entrance Kiosk Swiping a membership card at the clubs entrance terminal during the promotional period. Members will be entitled to one (1) entry per day.
- 2.2 Members gaining entry will automatically go into the virtual barrel before the draw date to be eligible. The virtual barrel will remain full for the entire promotional period.

#### 3. Draws and Prizes

- 3.1 There will be One (1) draw conducted from the **Sports Travel Experience Virtual Draw** on the following date: Friday 7<sup>th</sup> November 2025
- 3.2 For the draw there will be 1 (one) winner drawn out of all entries in the virtual barrel. The winner will be given 2 (Two) minutes to make themselves known to drawer. The winner's name and membership number will be announced over the Clubs internal PA system.
- 3.3 If the winner is not present after 2 minutes the prize will be again drawn, and this will continue until a winner is present.
- 3.4 There will be one (1) major prize, provided by ACBC which provides the winner a \$3000 sport and travel voucher from TASA.
- 3.5 The prize is valid for 3 years from date of issue and can be used for any of TASA's Sports or Travel products. (for full terms and conditions www.tasa.com.au)
- 3.6 The prize cannot be used for match tickets only. All match tickets must be sold as a package
- 3.7 Only one prize will be given away
- 3.8 The prize is non-refundable and cannot be redeemed for cash

#### 4. Identification

4.1 Winners must be present to claim their prize and they must produce a financial membership card to claim their prize.

#### 5. General

General

- 5.8 Participation in the Promotion by a patron confirms acceptance of the terms and conditions of the Promotion and the Club's Rules and By-Laws in force from time to time.
