### **Terms & Conditions**

#### 1. Promotional Period

1.1 Armidale City Bowling Club (ACBC) "110 Year Anniversary Celebrations" promotion ("Promotion") commences at 9am on the 20<sup>th</sup> November 2023 with the final draw on Friday 10<sup>th</sup> May 2024 at 7pm.

#### 2. Entry Requirements

2.1 Entry is open to all financial members of ACBC and is via:
Food & Beverage Spend (bar, café or restaurant) – following a spend of \$20 or more in ONE transaction, members will receive a VIRTUAL ticket/ entry into the promotion. Members will be entitled to one entry per \$20 spend and must be a financial member at the time of the promotion commencing.

2.2 Members' virtual entries will remain in the virtual barrel for the duration of the promotion. The barrel will remain full for the entire promotional period.

#### 3. Draws and Prizes

- 3.1 There will be ONE (1) draw conducted from the virtual barrel on Friday, 10th May 2024.
- 3.2 The winner's name and membership number will be announced over the Clubs internal PA system.
- 3.3 If the winner is not present after 2 minutes the prize will be again drawn, and this will continue until a winner is present.
- 3.4 There will be one (1) major prize, provided by ACBC of a \$36,000 Mazda CX30
- 3.5 The prize providers are Armidale City Bowling Club
- 3.6 Only the amounts listed on the draw dates will be given away

#### 4. Identification

4.1 Winners of the prize must be present to claim their prize and they must produce a financial membership card to claim their prize.

#### 5. General

General

- 5.1 Prize winners are advised that Tax implications may arise from their prize winnings and they should seek independent financial advice prior to the acceptance of the prize.
- 5.2 ACBC is the promoter. The promoter reserves the right to refuse to allow a winner to take part in any or all aspects of the prize, if the promoter determines, in their absolute discretion, that a winner is not in the mental or physical condition necessary to be able to safely participate in the prize.
- 5.3 ACBC reserves the right to cancel or change the prizes offered under this promotion if there are any changes to the law which would render the promotion, or any prizes offered under the promotion unlawful
- 5.4 It is a condition of accepting the prize that the winner *may be* required to sign a legal release in a form determined by the promoter in its absolute discretion.

- 5.7 Staff members and directors are eligible to participate in the Promotion.
- 5.8 Participation in the Promotion by a patron confirms acceptance of the terms and conditions of the Promotion and the Club's Rules and By-Laws in force from time to time.
- 5.9 Should a prize winner consent to having his/her photograph taken, that selected prize winner consents to having his/her name and photograph published in any form of media and agrees to participate in any reasonable promotion requested by ACBC.
- 5.10 If for any reason this promotion is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the promoter, which corrupt or affect the administration security, fairness or integrity or proper conduct of this promotion, the promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process.

The promoter may use the entrants' names, addresses and telephone numbers for the distribution of prizes as well as future promotional, marketing and publicity purposes in any media worldwide without notice and without any fee being paid unless otherwise advised by the entrant.
