Sapphire Paste

Process description:

Sapphire Paste is a ready-to-use rodenticide bait containing 0.004% brodifacoum pasta sachet formulation. It is used for controlling brown rats and house mice. The product is to be used in and around buildings and in burrows.

Application:

For rat infestations, use bait points of 60g placed 10m apart, reducing to 60g in each bait point in 5m apart in high infestations. In burrows, 60-100g to be placed in each burrow.

For mouse infestations, use bait points of 10g placed 5m apart, reducing to 10g per bait point placed at 3m apart in high infestations.

Baits should be securely deposited to minimize the risk of consumption by non-target animals and should be placed in bait stations or other covered bait points.
