## **Basic Services of the funeral director, staff, and overhead: \$695**

This fee for our basic services will be added to the total cost of the funeral arrangements you select. The fee is already included in our charge for direct cremations, immediate burials, and forwarding or receiving remains. This fee includes:

- Personnel available 24 hours a day, 365 days a year to respond to the initial call.
- Arrangement conference.
- Coordinating service plans with cemetery, crematory, and/or other parties involved in the final disposition of the deceased.
- Clerical assistance in the completion of various forms and permits associated with a funeral.
- Overhead, included facility maintenance, equipment and inventory costs, insurance, and administrative expenses, and governmental compliance.

## **Minimum Services**

Minimum services are a “direct cremation” or “immediate burial.” These are reduced-cost services without a ceremony. The price ranges are the minimum services plus the cost of a casket selected from our casket price list.

## **Direct Cremation Services Included: \$1,695**

- Initial transport of the body from an Orange County location to our licensed refrigerated holding facility in Anaheim, CA.
- Caring for the body prior to cremation.
- Preparing the death certificate.
- One (1) Disposition Burial / Cremation permit (Health Department Fee).
- California State regulatory fee.
- Coordinating with the local medical examiner / coroner if required.

### **Forwarding of Remains**

Forwarding remains is the preparation and process of transferring a loved one to a funeral home out of the area. This includes basic services, transfer of the deceased to the funeral home, care and handling of the deceased, and transportation to a common carrier or other funeral home within 30 miles. (Embalming, Casket, Air tray, and Carrier fees are not included.)

## **Receiving of Remains**

**\$1,345**

Receiving of remains is when we receive a loved one from a funeral home out of the area. This includes reduced basic services, transfer of deceased from the common carrier to local funeral home, sheltering and transportation to cemetery or crematory.

## **Services and Packages**

### **Cremation with Identification Viewing:**

**\$2,170**

Includes basic service fee, transfer of deceased into our care, sheltering of the remains, cremation process, alternative container, staff, and coordination for 30-minute viewing for immediate family. (Does not include additional preparation costs if desired)

### **Cremation with Witness Cremation and/or Viewing:**

**\$2,350**

Includes basic service fee, transfer of deceased into our care, sheltering of the remains, cremation process, alternative container, staff, and coordination for 1-hour viewing for immediate family. (Does not include additional preparation costs if desired)

### **Burial with Graveside Service:**

**\$4,645**

Includes basic service fee, transfer of the deceased into our care, sheltering of the remains, dressing, and casketing, coach for transportation to the cemetery and the staff for the graveside service. (Casket not included)

## Natural Organic Reduction

Natural Organic Reduction (NOR), also known as Terramation, utilizes the body's own naturally occurring microbes to gently transform remains into nutrient-rich soil. The process is conducted in individual vessels and takes 60-90 days to complete. The resulting soil can then be returned home to be placed in cemeteries, gardens, house plants, memorial trees, or donated to a Woodland property in Kent, WA to aid in the restoration and rejuvenation of a Washington forest.

### **Terramation**

**\$6,995**

- Basic service fee of funeral director and staff.
- Transfer of remains to funeral home.
- Sheltering, preparation, care and handling of remains.
- Bathing and dressing in a compostable garment.
- One hour viewing in our mock vessel.
- Transfer of remains to Natural Organic Reduction facility.
- Transportation to a common carrier and coordination with Return Home for transport to Seattle.
- Airtray for transportation.
- Disposition of remains into compost through the process of Terramation (NOR).
- Packaging and pickup of soil at the facility.
- Airline (common carrier) fees and destination funeral charges are not included.
- Can only ship soil within the United States. (Additional Charges Apply)
